### STATE OF OKLAHOMA AMENDMENT NO. 3 TO STATEWIDE CONTRACT AMENDMENT CONTRACT WITH DELL MARKETING L.P.

This Third Amendment to Oklahoma Statewide Contract No. 1020 with Dell Marketing L.P. (the "Third Amendment") is effective as of the date of the last signature below, between the State of Oklahoma by and through the Office of Management and Enterprise Services and Dell Marketing L.P. ("Supplier"). This Third Amendment supplements and amends Oklahoma Statewide Contract No. 1020 entered into by the parties and effective July 20, 2023, including all supplements and amendments thereto. Unless otherwise indicated herein, capitalized terms used in this Amendment without definition shall have the respective meanings specified in the Contract.

For good and valuable consideration, the parties agree to amend the Contract as follows:

1. The Parties agree to amend section 3 of the Cover Page of the Contract to add the following language as subsection 3.6:

"The Parties agree that the procurement of Dell data center equipment, under Categories 5, 6, and 7 of Exhibit 1, may be made through Dell's authorized resellers under the terms and conditions of the Contract (SW1020 with Dell). Additionally, the parties agree that resellers are not authorized to modify, waive or otherwise alter any rights or obligations under the Contract.

The Parties further agree that the following entities are recognized as authorized resellers for purposes of this Contract:

- a. Davenport Group
- b. The Redesign Group
- c. InterWorks, Inc.
- d. SHI International Corp.
- e. CDW Government, LLC
- f. World Wide Technology, LLC
- g. Computacenter
- h. NTT Data Group
- i. Business Imaging Systems Inc."

2. In the event of a conflict between the terms and conditions hereof and the terms and conditions of the Contract, the specific terms set forth in this Amendment shall govern the subject matter herein.
3. Except as expressly modified in this Amendment, all terms and/or provisions of the Contract not addressed herein remain as executed by the parties in the Contract and remain in full force and effect.
4. This Amendment may be executed by electronic signature in counterparts (e-mail, facsimile or otherwise). The counterparts each of which shall constitute an original, but all of which together shall constitute one and the same instrument.
