1. Whereas 59 O.S. § 328.15(16) authorizes the board to inform and educate all license and permit holders regarding the State Dental Act; and
2. Whereas HB 1948 requires every licensed dentist to check the Prescription Monitoring Program prior to writing new prescriptions for Opiates, Synthetic Opiates, Semisynthetic Opiates, Benzodiazepine and Carisoprodol, or any refills after 180 days; and
3. Whereas the Board is daily receiving calls for dentists just now being made aware of the new law and requesting training and assistance; and
4. The Board hereby resolves that the Dentistry Board staff shall work with the Oklahoma Bureau of Narcotics and other agencies to ensure that every licensed dentist is made aware of the law and is signed up for access to the PMP; and
