1. Meeting called to Order
2. Discussion and possible consideration of Board guidance and recommendations of Dentists Response and Safety Protocols for COVID-19.

The Board intends to have a discussion and seeks information and input from invited guests representing dentistry organizations and dental specialties. The focus of this discussion will include but not be limited to the following subtopics:
