

**AGREED ORDER FOR CONTINUANCE OF HEARING**

1. The Board of Dentistry ("Board") has jurisdiction over the practice of dentistry, individuals licensed to practice dentistry in the State of Oklahoma and this proceeding pursuant to the State Dental Act ("Act"), Title 59 O.S., § 328.1 et. seq., and its predecessor statutes.

2. In the Matter of the Complaint against WAYNE SCOTT HARRINGTON, D.M.D. license # 3666, issued June 23, 1974 and Oral Surgery Specialty license # 59, issued June 10 1977, is set to be heard before the Board of Dentistry on August 16, 2013.


3. Both parties are in need of additional time to complete witness interviews, depositions and attend to other pre-trial matters.

4. This is the first continuance in this matter and is not for the purpose of undue delay.

4. By agreement of the parties, the hearing is reset to January 17, 2014 at 9:00 a.m. at the Board of Dentistry, 2920 N. Lincoln Blvd., Suite B, Oklahoma City, OK 73105.

5. The temporary suspension of Dr. Harrington's license, which was agreed to by the parties on April 12, 2013, shall remain in full force pending a full and final hearing set for January 17, 2014.


