

1 public's best interest. It is further declared to be a matter of
2 public interest and concern that the dental profession, through
3 advancement and achievement, merits and receives the confidence of
4 the public and that only properly qualified dentists be permitted to
5 practice dentistry and supervise dental hygienists, dental
6 assistants ~~and~~, oral maxillofacial surgery assistants and
7 orthodontic assistants in the State of Oklahoma. All provisions of
8 this act relating to the practice of dentistry, the practice of
9 dental hygiene, the procedures performed by dental assistants ~~and~~,
10 oral maxillofacial surgery assistants and orthodontic assistants,
11 and the fabrication of dental appliances in dental laboratories by
12 dental laboratory technicians shall be liberally construed to carry
13 out these objects and purposes.

14 SECTION 2. AMENDATORY 59 O.S. 2011, Section 328.3, as
15 amended by Section 2, Chapter 405, O.S.L. 2013 (59 O.S. Supp. 2013,
16 Section 328.3), is amended to read as follows:

17 Section 328.3 As used in the State Dental Act, the following
18 words, phrases, or terms, unless the context otherwise indicates,
19 shall have the following meanings:

20 1. "Accredited dental college" means an institution whose
21 dental educational program is accredited by the Commission on Dental
22 Accreditation of the American Dental Association;

23

1 2. "Accredited dental hygiene program" means a dental hygiene
2 educational program which is accredited by the Commission on Dental
3 Accreditation of the American Dental Association;

4 3. "Accredited dental assisting program" means a dental
5 assisting program which is accredited by the Commission on Dental
6 Accreditation of the American Dental Association;

7 4. "Board" means the Board of Dentistry;

8 ~~4.~~ 5. "Dentistry" means the practice of dentistry in all of its
9 branches;

10 ~~5.~~ 6. "Dentist" means a graduate of an accredited dental
11 college who has been issued a license by the Board to practice
12 dentistry as defined in Section 328.19 of this title;

13 ~~6.~~ 7. "Dental ambulatory surgical center" or "DASC" means a
14 facility that operates exclusively for the purpose of furnishing
15 outpatient surgical services to patients. A DASC shall have the
16 same privileges and requirements as a dental office and additionally
17 must be an accredited facility;

18 8. "Dental office" means an establishment owned and operated by
19 a dentist for the practice of dentistry, which may be composed of
20 reception rooms, business offices, private offices, laboratories,
21 and dental operating rooms where dental operations are performed;

22 ~~7.~~ 9. "Dental hygienist" means an individual who has fulfilled
23 the educational requirements and is a graduate of an accredited
24 dental hygiene program and who has passed an examination and has

1 been issued a license by the Board and who is authorized to practice
2 dental hygiene as hereinafter defined;

3 ~~8.~~ 10. "Dental assistant ~~or~~, oral maxillofacial surgery
4 assistant or orthodontic assistant" means an individual working for
5 a dentist, under the dentist's direct supervision or direct visual
6 supervision, and performing duties in the dental office or a
7 treatment facility, including the limited treatment of patients in
8 accordance with the provisions of the State Dental Act. A dental
9 assistant ~~or~~, oral maxillofacial surgery assistant or orthodontic
10 assistant may assist a dentist with the patient; provided, this
11 shall be done only under the direct supervision or direct visual
12 supervision and control of the dentist and only in accordance with
13 the educational requirements and rules promulgated by the Board;

14 ~~9.~~ 11. "Dental laboratory" means a location, whether in a
15 dental office or not, where a dentist or a dental laboratory
16 technician performs dental laboratory technology;

17 ~~10.~~ 12. "Dental laboratory technician" means an individual
18 whose name is duly filed in the official records of the Board, which
19 authorizes the technician, upon the laboratory prescription of a
20 dentist, to perform dental laboratory technology, which services
21 must be rendered only to the prescribing dentist and not to the
22 public;

23 ~~11.~~ 13. "Dental laboratory technology" means using materials
24 and mechanical devices for the construction, reproduction or repair

1 of dental restorations, appliances or other devices to be worn in a
2 human mouth;

3 ~~12.~~ 14. "Dental specialty" means a specialized practice of a
4 branch of dentistry, recognized and defined by the American Dental
5 Association ~~and the rules of~~ or by the Board;

6 ~~13.~~ 15. "Direct supervision" means the supervisory dentist is
7 in the dental office or treatment facility and, during the
8 appointment, personally examines the patient, diagnoses any
9 conditions to be treated, and authorizes the procedures to be
10 performed by a dental hygienist, dental assistant, ~~or~~ oral
11 maxillofacial surgery assistant, ~~remains~~ or orthodontic assistant.
12 The supervising dentist is continuously on site and physically
13 present in the dental office or treatment facility while the
14 procedures are being performed and, before dismissal of the patient,
15 evaluates the results of the dental treatment;

16 ~~14.~~ 16. "Direct visual supervision" means the supervisory
17 dentist has direct ongoing visual oversight which shall be
18 maintained at all times during any procedure authorized to be
19 completed by a dental hygienist or an oral maxillofacial dental
20 assistant. Direct visual supervision shall only be required by a
21 dentist with a general anesthesia permit during a general anesthesia
22 procedure;

23 17. "General supervision" means the supervisory dentist has
24 ~~previously~~ diagnosed any conditions to be treated within the past

1 thirteen (13) months, has personally authorized the procedures to be
2 performed by a dental hygienist, and will evaluate the results of
3 the dental treatment within a reasonable time as determined by the
4 nature of the procedures performed, the needs of the patient, and
5 the professional judgment of the supervisory dentist. General
6 supervision and indirect supervision may only be used in supervising
7 dental hygienists;

8 ~~15.~~ 18. "Indirect supervision" means the supervisory dentist is
9 in the dental office or treatment facility and has personally
10 diagnosed any conditions to be treated, authorizes the procedures to
11 be performed by a dental hygienist, remains in the dental office or
12 treatment facility while the procedures are being performed, and
13 will evaluate the results of the dental treatment within a
14 reasonable time as determined by the nature of the procedures
15 performed, the needs of the patient, and the professional judgment
16 of the supervisory dentist;

17 ~~16.~~ 19. "Investigations" means an investigation proceeding,
18 authorized under Sections 328.15A and 328.43a of this title, to
19 investigate alleged violations of the State Dental Act or the rules
20 of the Board;

21 ~~17.~~ 20. "Laboratory prescription" means a written description,
22 dated and signed by a dentist, of dental laboratory technology to be
23 performed by a dental laboratory technician;

24

1 ~~18.~~ 21. "Out-of-state dental hygienist" means a graduate of an
2 accredited dental hygienist program who holds a license to practice
3 dental hygiene in another state but who is not licensed to practice
4 dental hygiene in this state;

5 ~~19.~~ 22. "Out-of-state dentist" means a graduate of an
6 accredited dental college who holds a license to practice dentistry
7 in another state but who is not licensed to practice dentistry in
8 this state;

9 ~~20.~~ 23. "Patient" or "patient of record" means an individual
10 who has given a medical history and has been examined and accepted
11 ~~for dental care by a dentist~~ for dental care;

12 ~~21.~~ ~~"Retired dentist" means a person that has a current active~~
13 ~~dental or specialty license but is limited to practicing in a~~
14 ~~volunteer nonpaid capacity;~~

15 ~~22.~~ 24. "Specialty assistant" means an oral maxillofacial
16 assistant or an orthodontic assistant as defined by Section 328.25
17 of this title;

18 25. "Supervision" means direct supervision, direct visual
19 supervision, indirect supervision, or general supervision; and

20 ~~23.~~ 26. "Treatment facility" means:

- 21 a. a federal, tribal, state or local public health
22 facility,
23 b. a federal qualified health care facility (FQHC),
24 c. a private health facility,

- 1 ~~e.~~ d. a group home or residential care facility serving the
2 elderly, handicapped or juveniles,
3 ~~d.~~ e. a hospital,
4 ~~e.~~ f. a nursing home,
5 ~~f.~~ g. a penal institution operated by or under contract with
6 the federal or state government,
7 ~~g.~~ h. a public or private school,
8 ~~h.~~ i. a patient of record's private residence,
9 ~~i.~~ j. a mobile dental ~~unit~~ facility,
10 ~~j.~~ ~~an accredited~~
11 k. a dental college accredited by the Commission on

20 SECTION 3. AMENDATORY 59 O.S. 2011, Section 328.10, is
21 amended to read as follows:

22 Section 328.10 A. The Board of Dentistry shall organize
23 annually at the last regularly scheduled meeting of the Board before
24 the beginning of each fiscal year, by electing from among its

1 members a president, a first vice-president, a second vice-
2 president, and a secretary-treasurer. The duties of each officer
3 shall be prescribed in the rules of the Board. The term of office
4 of the persons elected president, vice-presidents and secretary-
5 treasurer shall be for the following fiscal year and until their
6 successors are elected and qualified.

7 B. The Board shall hold regularly scheduled meetings during
8 each quarter of the year at a time and place determined by the Board
9 and may hold such additional regular meetings, special meetings,
10 emergency meetings, or continued or reconvened meetings as found by
11 the Board to be expedient or necessary. A majority of the Board
12 shall constitute a quorum for the transaction of business.

13 ~~C. The Board may appoint an individual to be the principal
14 administrative officer of the Board and may confer upon that person
15 the title selected by the Board, based upon the person's education,
16 background, experience and ability. The principal administrative
17 officer shall be responsible for the performance of administrative
18 functions delegated by the Board.~~

19 ~~D. The Board shall act in accordance with the provisions of the
20 Oklahoma Open Meeting Act, the Oklahoma Open Records Act and the
21 Administrative Procedures Act.~~

22 ~~E. All members of the Board and such employees, as determined
23 by the Board, shall be bonded as required by Sections 85.26 through
24 85.31 of Title 74 of the Oklahoma Statutes.~~

1 ~~F. The responsibilities and rights of any member or employee of~~
2 ~~the Board who acts within the scope of Board duties or employment~~
3 ~~shall be governed by the Governmental Tort Claims Act.~~

4 ~~G.~~ Members of the Board shall serve without compensation but
5 shall be reimbursed for all actual and necessary expenses incurred
6 in the performance of their duties in accordance with the State
7 Travel Reimbursement Act.

8 D. Committee members and anesthesia inspectors appointed by the
9 Board shall be eligible for reimbursement for travel expenses in
10 accordance with the State Travel Reimbursement Act.

11 SECTION 4. AMENDATORY 59 O.S. 2011, Section 328.15, as
12 last amended by Section 3, Chapter 405, O.S.L. 2013 (59 O.S. Supp.
13 2013, Section 328.15), is amended to read as follows:

14 Section 328.15 A. Pursuant to and in compliance with Article I
15 of the Administrative Procedures Act, the Board of Dentistry shall
16 have the power to formulate, adopt, and promulgate rules as may be
17 necessary to regulate the practice of dentistry in this state and to
18 implement and enforce the provisions of the State Dental Act.

19 B. The Board is authorized and empowered to:

20 1. Examine and test the qualifications of applicants for a
21 license or permit to be issued by the Board;

22 2. Affiliate by contract or cooperative agreement with another
23 state or combination of states for the purpose of conducting
24

1 simultaneous regional examinations of applicants for a license to
2 practice dentistry, dental hygiene, or a dental specialty;

3 3. Maintain a list of the name, current mailing address and
4 principal office address of all persons who hold a license or permit
5 issued by the Board;

6 4. Account for all receipts and expenditures of the monies of
7 the Board, including annually preparing and publishing a statement
8 of receipts and expenditures of the Board for each fiscal year;

9 5. Within limits prescribed in the State Dental Act, set all
10 fees and administrative penalties to be imposed and collected by the
11 Board;

12 6. Employ an Executive Director, legal counsel and other
13 advisors to the Board, including advisory committees;

14 7. Investigate and issue investigative and other subpoenas,
15 pursuant to Article II of the Administrative Procedures Act;

16 8. Initiate individual proceedings and issue orders imposing
17 administrative penalties, pursuant to Article II of the
18 Administrative Procedures Act, against any dentist, dental
19 hygienist, dental assistant, oral maxillofacial surgery assistant,
20 orthodontic assistant, dental laboratory technician, or holder of a
21 permit to operate a dental laboratory who has violated the State
22 Dental Act or the rules of the Board;

23 9. Conduct, in a uniform and reasonable manner, inspections of
24 dental offices and dental laboratories and their business records;

1 10. Establish guidelines for courses of study necessary for
2 dental assistants, oral maxillofacial surgery assistants,
3 orthodontic assistants and, when appropriate, issue permits
4 authorizing dental assistants to perform expanded duties;

5 11. Establish continuing education requirements for dentists,
6 dental hygienists, dental assistants ~~and~~, oral maxillofacial surgery
7 assistants and orthodontic assistants who hold permits issued by the
8 Board;

9 12. Recognize the parameters and standards of care established
10 and approved by the American Dental Association;

11 13. Formulate, adopt, and promulgate rules, pursuant to Article
12 I of the Administrative Procedures Act, as may be necessary to
13 implement and enforce the provisions of the Oklahoma Dental
14 Mediation Act;

15 14. Seek and receive advice and assistance of the Office of the
16 Attorney General of this state;

17 15. Promote the dental health and education of dental health of
18 the people of this state;

19 16. Inform, educate, and advise all persons who hold a license
20 or permit issued by the Board, or who are otherwise regulated by the
21 Board, regarding the State Dental Act and the rules of the Board;

22 17. Affiliate with the American Association of Dental Boards as
23 an active member, pay regular dues, and send members of the Board as
24 delegates to its meetings;

1 18. Enter into contracts;

2 19. Acquire by purchase, lease, gift, solicitation of gift or
3 by any other manner, hold, encumber, and dispose of personal
4 property as is needed, maintain, use and operate or contract for the
5 maintenance, use and operation of or lease of any and all property
6 of any kind, real, personal or mixed or any interest therein unless
7 otherwise provided by the State Dental Act; provided, all contracts
8 for real property shall be subject to the provisions of Section 63
9 of Title 74 of the Oklahoma Statutes;

10 20. Acquire items through purchase or donation with historical
11 significance related to the Oklahoma Dental Board or the Territorial
12 Dental Board of Oklahoma;

13 21. Receive or accept the surrender of a license, permit, or
14 certificate granted to any person by the Board as provided in
15 Section 328.44a of this title; and

16 ~~21.~~ 22. Take all other actions necessary to implement and
17 enforce the State Dental Act.

18 SECTION 5. AMENDATORY 59 O.S. 2011, Section 328.17, is
19 amended to read as follows:

20 Section 328.17 A. 1. The Board of Dentistry shall have ~~power~~
21 ~~to appoint one dental hygienist in an advisory capacity to sit with~~
22 ~~the Board to:~~

23 ~~1. Assist the Board in the administration and enforcement of~~
24 ~~the dental hygienist provisions of the State Dental Act; and~~

1 ~~2. Be present only at a Board meeting when the agenda of the~~
2 ~~meeting includes matters pertinent to the administration and~~
3 ~~enforcement of the dental hygiene provision of the State Dental Act.~~

4 ~~B. The appointment shall be made from a list of names submitted~~
5 ~~to the Board by the dental hygienists of this state.~~

6 ~~C. The appointment shall be for a period of two (2) years or~~
7 ~~until a successor is appointed. the following standing committees~~
8 ~~that shall meet once per year and other times as needed to study~~
9 ~~issues affecting the practice of dentistry and the safety of the~~
10 ~~public and to make recommendations to the Board:~~

11 a. Dental Practice Committee,

12 b. Historical and Retirement Committee,

13 c. Assistants, Dental Labs and Other Auxiliary Personnel
14 Committee,

15 d. Specialty Practice Committee, and

16 e. Anesthesia Committee.

17 2. Each committee shall be cochaired by a current or past Board
18 member to be appointed by the Board President and a member of a
19 statewide organization representing dentists as recommended by such
20 organization.

21 3. Each committee may have up to ten committee members with the
22 exception of the Anesthesia Committee which may have up to eighteen
23 members exclusive of the cochairs.

1 4. The Board President shall appoint all committee members.
2 One-half (1/2) of the committee members shall be recommended by the
3 Board and one-half (1/2) of the committee members shall be
4 recommended to the Board President by a statewide organization
5 representing dentists.

6 5. Committee members shall be on staggered three-year terms and
7 shall serve at the pleasure of the Board.

8 B. There shall be a Dental Hygiene Advisory Committee:

9 1. The Dental Hygiene Advisory Committee shall be composed of
10 the following members:

11 a. one current dental hygiene member of the Board, and

12 b. two dental hygienists recommended by the Board and two
13 dental hygienists recommended by a statewide
14 organization representing dental hygienists;

15 2. The Committee shall have the following functions:

16 a. to develop and propose recommendations to the Board
17 regarding the education, examination, licensure, and
18 regulation of dental hygienists,

19 b. to advise the Board in rulemaking regarding dental
20 hygiene,

21 c. to hold meetings at least annually but not more than
22 four times a year,

23

24

1 d. to work directly with the Allied Dental Education
2 Committee in reviews and recommendations for
3 equivalent programs; and

4 3. Members of the Committee shall be appointed by the Board and
5 shall serve a term of three (3) years. Appointments shall be made
6 so that approximately one-third (1/3) of the Committee is
7 reappointed at any given time. Members may be appointed for
8 consecutive terms if recommended by the Board President.

9 C. There shall be an Allied Dental Education Committee. This
10 Committee shall review the standards and equivalency of in-state and
11 out-of-state dental and auxiliary program requirements.

12 1. The Board President shall appoint all members of the Allied
13 Dental Education Committee upon approval by the Board.

14 2. The Committee shall have the authority to evaluate
15 individual credentials and programs for the purpose of issuing
16 dental assistant expanded duty permits and dental hygiene advanced
17 procedure permits based on criteria as defined by the State Dental
18 Act and other statutes and shall make recommendations to the Board.

19 3. The Committee shall set the standards and review criteria
20 for all programs for advanced procedures of dental hygienists and
21 expanded duties for dental assistants from programs that are
22 providers approved by the Commission on Dental Accreditation (CODA),
23 or a program approved by the Board. The Board may consider current
24

1 technology and other methods of education when evaluating a program
2 for approval.

3 4. The Committee shall meet as necessary.

4 5. The Committee may have up to six members of whom three shall
5 have a background in dental education in addition to the Dental
6 Hygiene Board member and the Board President or his designees.

7 6. Committee members shall serve staggered three-year terms and
8 serve at the pleasure of the Board.

9 D. The Board President shall have the authority to appoint
10 other ad hoc committees as needed.

11 SECTION 6. AMENDATORY 59 O.S. 2011, Section 328.19, as
12 amended by Section 4, Chapter 405, O.S.L. 2013 (59 O.S. Supp. 2013,
13 Section 328.19), is amended to read as follows:

14 Section 328.19 A. The following acts by any person shall be
15 regarded as practicing dentistry within the meaning of the State
16 Dental Act:

17 1. Representing oneself to the public as being a dentist or as
18 one authorized to practice dentistry;

19 2. Representing oneself to the public as being able to diagnose
20 or examine clinical material and contract for the treating thereof;

21 3. Treating or professing to treat by professional
22 instructions;

- 1 4. Representing oneself to the public as treating any of the
2 diseases or disorders or lesions of the oral cavity, teeth, gums,
3 maxillary bones, and associate structures;
- 4 5. Removing human teeth;
- 5 6. Repairing or filling cavities in human teeth;
- 6 7. Correcting or attempting to correct malposed teeth;
- 7 8. Administering anesthetics, general or local;
- 8 9. Treating deformities of the jaws and adjacent structures;
- 9 10. Using x-ray and interpreting dental x-ray film;
- 10 11. Offering or undertaking, by any means or methods, to remove
11 stains, discolorations, or concretions from the teeth;
- 12 12. Operating or prescribing for any disease, pain, injury,
13 deficiency, deformity, or any physical condition connected with the
14 human mouth;
- 15 13. Taking impressions of the teeth and jaws;

19 other substitutes for natural teeth for the user or prospective user
20 thereof;
- 21 15. Adjusting or attempting to adjust any prosthetic denture,
22 bridge, appliance, or any other structure to be worn in the human
23 mouth;

1 16. Diagnosing, making, and adjusting appliances to artificial
2 casts of malposed teeth for treatment of the malposed teeth in the
3 human mouth, without instructions;

4 17. Writing a laboratory prescription to a dental laboratory or
5 dental laboratory technician for the construction, reproduction or
6 repair of any appliance or structure to be worn in the human mouth;
7 ~~or~~

8 18. Owning, maintaining, or operating an office or offices by
9 holding a financial interest in same for the practice of dentistry;
10 or

11 19. Any other procedure otherwise defined in the State Dental
12 Act requiring a valid license or permit to perform while the person
13 does not hold such valid license or permit.

14 B. The fact that a person uses any dental degree, or
15 designation, or any card, device, directory, poster, sign or other
16 media representing oneself to be a dentist shall be prima facie
17 evidence that the person is engaged in the practice of dentistry;
18 provided, that nothing in this section shall be so construed as to
19 prevent the following:

20 1. Physicians or surgeons, who are licensed under the laws of
21 this state, from administering any kind of treatment coming within
22 the province of medicine or surgery;

23 2. The practice of dentistry in the discharge of their official
24 duties by dentists in the United States Army, the United States

1 Navy, the United States Air Force, the United States Marine Corps,
2 the United States Coast Guard, the United States Public Health
3 Service, or the United States Veterans Administration;

4 3. Dental schools or colleges, as now conducted and approved,
5 or as may be approved, and the practice of dentistry by students in
6 dental schools, colleges or hospitals, approved by the Board, when
7 acting under the direction and supervision of licensed dentists or
8 dentists holding properly issued permits acting as instructors;

9 4. Acts of a dental clinician or other participant at a dental
10 educational meeting or at an accredited dental college, when no fee
11 is charged to or paid by a patient;

12 5. The practice of dental hygiene, as defined herein, by a
13 person granted a license by the Board;

14 6. The practice of a registered nurse, licensed practical nurse
15 or certified nurse anesthetist holding a valid license issued by the
16 Oklahoma Board of Nursing while performing acts in a dental office
17 or facility under the supervision of a licensed dentist;

18 7. The performing of acts by a dental assistant ~~or~~, oral
19 maxillofacial surgery assistant, or orthodontic assistant who
20 performs the acts under the direct supervision or direct visual
21 supervision of a dentist and in accordance with the provisions of
22 the State Dental Act and the rules promulgated by the Board; or

23 ~~7.~~ 8. The fabrication of dental appliances pursuant to a
24 laboratory prescription of a dentist, by a dental laboratory

1 technician in a dental laboratory using inert materials and
2 mechanical devices for the fabrication of any restoration, appliance
3 or thing to be worn in the human mouth.

4 SECTION 7. AMENDATORY 59 O.S. 2011, Section 328.21, as
5 amended by Section 5, Chapter 405, O.S.L. 2013 (59 O.S. Supp. 2013,
6 Section 328.21), is amended to read as follows:

7 Section 328.21 A. No person, unless registered to practice
8 dentistry or dental hygiene in this state on July 1, 1970, shall
9 practice dentistry or dental hygiene without first applying for and
10 obtaining a license from the Board of Dentistry.

11 B. Application shall be made to the Board in writing and shall
12 be accompanied by the fee established by the rules of the Board,
13 together with satisfactory proof that the applicant:

14 1. Is of good moral character; ~~and~~

15 2. Is twenty-one (21) years of age, or over, at the time of
16 making application to practice dentistry or eighteen (18) years of
17 age, or over, if the applicant is to practice dental hygiene;

18 3. Has passed a written theoretical examination and a clinical
19 examination as approved by the Board; and

20 4. Has passed a written jurisprudence examination over the
21 rules and laws affecting dentistry in Oklahoma.

22 C. An application from a candidate who desires to secure a
23 license from the Board to practice dentistry or dental hygiene in
24

1 this state shall be accompanied by satisfactory proof that the
2 applicant ~~is~~:

3 1. ~~A~~ Is a graduate of an accredited dental college, if the
4 applicant is to practice dentistry; ~~or~~

5 2. ~~A~~ Is a graduate of an accredited dental hygiene program, if
6 the applicant is to practice dental hygiene.

2 administered by the dentist.

3 J. Oral maxillofacial surgical assistants shall be required to
4 complete twelve (12) hours of continuing education every three (3)
5 years in classes approved by the American Association of Oral
6 Maxillofacial Surgeons that are certified by the American Dental
7 Association CERP program or another program approved by the Board.
8 The continuing education requirement shall include at least one (1)
9 hour on infection control.

10 K. The anesthesia committee provided pursuant to Section 328.17
11 of this title may make a recommendation to the Board for an oral
12 maxillofacial surgical assistant holding a temporary training permit
13 to substitute training received in another state university, dental
14 school or technical training institute or training acquired in a
15 surgical center or hospital while working under the authority of a
16 licensed physician to qualify as a partial substitute for the
17 requirements to attain a full oral maxillofacial surgical assistant
18 permit.

19 L. An applicant for an orthodontic assistant permit shall
20 provide satisfactory proof of:

21 1. Successful completion of a training program specializing in
22 assisting of an orthodontist and approved by the Board;

23 2. Completion of an infection-control class approved by the
24 Board; and

1 3. Completion of a minimum of six (6) months of training by a
2 licensed orthodontist.

3 M. An orthodontic assistant that has completed all training
4 requirements shall receive a permit to practice as an orthodontic
5 assistant and shall have the authority to complete orthodontic
6 procedures as defined by the Board.

7 SECTION 14. AMENDATORY 59 O.S. 2011, Section 328.26, as
8 last amended by Section 7, Chapter 405, O.S.L. 2013 (59 O.S. Supp.
9 2013, Section 328.26), is amended to read as follows:

10 Section 328.26 A. The Board of Dentistry may, without
11 examination, issue a dental intern, resident or fellowship permit to
12 a student or graduate of an approved dental school or college, who
13 is otherwise qualified, upon request of the dean or the governing
14 body of any public or private institution for the graduate to serve
15 as a dental intern or resident in the institution, with limited
16 duties as defined in the permit.

17 B. A dental intern, resident or fellowship permit shall not be
18 issued to any person whose license to practice dentistry in this
19 state or in another state has been suspended or revoked, or to whom
20 a license to practice dentistry has been refused.

21 C. A dental intern, resident or fellowship permit shall not
22 authorize the holder to open an office for the private practice of
23 dentistry, or to receive compensation for the practice of dentistry,
24 except a salary paid by the federal government or this state, or

1 their subdivisions, or the public or private institution where the
2 holder of the dental intern, resident or fellowship permit will be
3 employed.

4 D. A dental intern, resident or fellowship permit shall
5 automatically expire when the permit holder is no longer
6 participating in the program offered by the college of dentistry or
7 the accredited dental college.

8 E. The issuance of a dental intern, resident or fellowship
9 permit by the Board shall in no way be considered a guarantee or
10 predetermination of any person to receive a full license issued by
11 the Board.

12 F. Dental intern or resident permits may be renewed annually at
13 the discretion of the Board.

14 G. A holder of a temporary license to practice dentistry or
15 dental hygiene shall have the same rights and privileges and be
16 governed by the State Dental Act and the rules of the Board in the
17 same manner as a holder of a permanent license to practice dentistry
18 and dental hygiene with the exceptions listed in this section.

19 H. Any student completing an externship in a dental assisting
20 program shall hold a current dental assistant permit as defined in
21 Section 328.24 of this title.

22 SECTION 15. AMENDATORY 59 O.S. 2011, Section 328.27, as
23 amended by Section 8, Chapter 405, O.S.L. 2013 (59 O.S. Supp. 2013,
24 Section 328.27), is amended to read as follows:

1 Section 328.27 A. 1. The Board of Dentistry may, without a
2 clinical examination, upon presentation of satisfactory credentials,
3 including completion of the dental hygiene National Boards and both
4 Part I and Part II of the National Board examination for dentists,
5 and under such rules as the Board may promulgate, issue a faculty
6 permit to an applicant who:

7 a. is a graduate of a school of dentistry approved by the
8 Board and is licensed to practice dentistry in another
9 state or country,

10 b. successfully completes advanced training in a
11 specialty approved by the Commission on Dental
12 Accreditation of the American Dental Association, or

13 c. is a graduate of an accredited dental hygiene program
14 and is licensed to practice dental hygiene in another
15 state.

16 2. A faculty permit shall be issued only upon the certification
17 of the dean of an accredited dental college or the director of an
18 accredited dental hygiene program located in this state that the
19 applicant is a bona fide member of the teaching staff of that
20 college or program.

21 3. Following the first year of employment, the faculty permit
22 holder shall show proof of passing an appropriate clinical board
23 examination recognized by the Board of Dentistry.

1 4. A faculty permit shall be valid for one (1) year and may be
2 renewed by the Board at the written request of the dean of an
3 accredited dental program or the director of an accredited dental
4 hygiene program.

5 B. The holder of a faculty permit shall be entitled to perform
6 services and procedures in the same manner as a person holding a
7 license to practice dentistry or dental hygiene in this state, but
8 all services and procedures performed by the faculty permit holder
9 shall only be without compensation other than that received in
10 salary from a faculty position or through faculty practice as
11 authorized by the Board. Such services and procedures shall be
12 performed only within the facilities of an accredited dental college
13 or accredited dental hygiene program or in a seminar or postgraduate
14 course and as an adjunct to teaching functions. A holder of a
15 faculty permit shall only engage in faculty practice of dentistry or
16 dental hygiene within the facilities designated by the accredited
17 dental college and including teaching hospitals approved by the
18 Board.

19 C. The Dean of an accredited dental or hygiene program may
20 petition the Board to allow a visiting faculty member to have a
21 visiting faculty permit not to exceed one (1) year, based on a
22 showing of criteria that the individual possesses specialty
23 knowledge in a specific area that would benefit the college or
24 program.

1 D. Upon request of the Dean, the Board President may issue a
2 dentist or hygienist licensed in another state or country a
3 temporary license pursuant to Section 328.23 of this title for the
4 purpose of attending a seminar or live training in dental techniques
5 or dental anesthesia, given at the University of Oklahoma College of
6 Dentistry to licensed dentists and hygienists for continuing
7 education credits and students enrolled in the University of
8 Oklahoma College of Dentistry. A temporary permit issued for this
9 purpose shall not exceed seven (7) days and may not be issued to the
10 same person more than four times in a calendar year.

11 E. Upon the request of the Oklahoma Dental Association
12 President or the Oklahoma Dental Hygiene Association President, the
13 Board President may issue a dentist or a hygienist licensed in
14 another state a temporary license pursuant to Section 328.23 of this
15 title for the purpose of attending live demonstrations during the
16 Oklahoma Dental Association or Oklahoma Dental Hygiene Association
17 annual meeting. A temporary permit issued for this purpose shall
18 not exceed four (4) days per calendar year.

19 SECTION 16. AMENDATORY Section 6, Chapter 270, O.S.L.

23 applicant for any type of license or permit issued by the Board of
24 Dentistry shall be subject to a criminal background check.

1 B. Each applicant shall submit two completed fingerprint cards
2 as required by the Board. The fingerprint cards shall be required
3 to be in a clear, readable format acceptable to the Oklahoma State
4 Bureau of Investigation.

5 C. Each applicant shall include a money order or cashier's
6 check made payable to the Oklahoma State Bureau of Investigation or
7 the Board for the purposes of a local and national criminal
8 background check.

9 D. The Board shall forward the fingerprint cards, along with
10 the applicable fee for a national fingerprint criminal history
11 records search, to the Bureau.

12 E. The Bureau shall retain one set of fingerprints in the
13 Automated Fingerprint Identification System and submit the other set
14 to the Federal Bureau of Investigation for a national criminal
15 history records search.

18 Section 328.31a A. One dentist or multiple dentists may use a
19 trade name in connection with the practice of dentistry provided
20 that:

- 21 1. The use of the trade name shall not be false, fraudulent or
22 misleading;
- 23 2. The name of the dentist or dentists actually providing the
24 dental services to the patient shall appear on all insurance claim

1 forms, billing invoices or statements sent to the patient and on all
2 receipts if any are given to the patient;

3 3. Treatment records shall be maintained for each patient that
4 clearly identify the dentist or dentists who performed all dental
5 services for the patient; and

6 4. When one dentist or multiple dentists make an advertisement
7 in the trade name or the trade name is included in an advertisement,
8 a copy of the advertisement, including but not limited to any
9 electronic form of the advertising, shall be kept by the dentist or
10 dentists for three (3) years from the first publication date of the
11 advertisement.

12 B. Beginning July 1, 2015, all advertisements for dentistry
13 shall include the name of the dentist or dentists that shall be
14 providing treatment and shall list the type of dental or specialty
15 license on the advertisement.

16 ~~B.~~ C. The Board of Dentistry shall promulgate rules regulating
17 advertisements in which one dentist or multiple dentists use a trade
18 name.

19 SECTION 19. NEW LAW A new section of law to be codified
20 in the Oklahoma Statutes as Section 328.31b of Title 59, unless
21 there is created a duplication in numbering, reads as follows:

22 A. Each licensed dentist shall maintain written records on each
23 patient that shall contain at a minimum the following information
24 about the patient:

1 1. A health history listing known illnesses, other treating
2 physicians and current medications prescribed;

3 2. Results of clinical examination and tests conducted,
4 including the identification, or lack thereof, of any oral pathology
5 or diseases;

6 3. Treatment plan proposed by the dentist; and

7 4. Treatment rendered to the patient. The patient record shall

16 B. Patient records may be kept in an electronic data format,
17 provided that the dentist maintains a back-up copy of information
18 stored in the data processing system using disk, tape or other
19 electronic back-up system and that said back-up is updated on a
20 regular basis, at least weekly, to assure that data is not lost due
21 to system failure. Any electronic data system shall be capable of
22 producing a hard copy on demand.

23 C. All patient records shall be maintained for seven (7) years
24 from the date of treatment.

1 D. Each licensed dentist shall retain a copy of each entry in
2 his or her patient appointment book or such other log, calendar,
3 book, file or computer data used in lieu of an appointment book for
4 a period of no less than seven (7) years from the date of each entry
5 thereon.

6 E. Patient records shall clearly identify the dentist or dental
7 hygienist providing the treatment along with their dental,
8 specialist or dental hygienist license number.

9 SECTION 20. AMENDATORY 59 O.S. 2011, Section 328.32, as
10 last amended by Section 12, Chapter 405, O.S.L. 2013 (59 O.S. Supp.
11 2013, Section 328.32), is amended to read as follows:

12 Section 328.32 A. The following acts or occurrences by a
13 dentist shall constitute grounds for which the penalties specified
14 in Section 328.44a of this title may be imposed by order of the
15 Board of Dentistry:

16 1. Pleading guilty or nolo contendere to, or being convicted
17 of, a felony, a misdemeanor involving moral turpitude, or a
18 violation of federal or state controlled dangerous substances laws;

19 2. Presenting to the Board a false diploma, license, or
20 certificate, or one obtained by fraud or illegal means;

21 3. Being, by reason of persistent inebriety or addiction to
22 drugs, incompetent to continue the practice of dentistry;

23 4. Publishing a false, fraudulent, or misleading advertisement
24 or statement;

1 5. Authorizing or aiding an unlicensed person to practice
2 dentistry, to practice dental hygiene, or to perform a function for
3 which a permit from the Board is required;

4 6. Authorizing or aiding a dental hygienist to perform any
5 procedure prohibited by the State Dental Act or the rules of the
6 Board;

7 7. Authorizing or aiding a dental assistant, orthodontic
8 assistant or oral maxillofacial surgery assistant to perform any
9 procedure prohibited by the State Dental Act or the rules of the
10 Board;

11 8. Failing to pay fees as required by the State Dental Act or
12 the rules of the Board;

13 9. Failing to complete continuing education requirements;

14 10. Representing himself or herself to the public as a
15 specialist in a dental specialty without holding a dental specialty
16 license therefor;

17 11. Representing himself or herself to the public as a
18 specialist whose practice is limited to a dental specialty, when
19 such representation is false, fraudulent, or misleading;

20 12. Endangering the health of patients by reason of having a
21 highly communicable disease and continuing to practice dentistry
22 without taking appropriate safeguards;

23 13. Practicing dentistry in an unsafe or unsanitary manner or
24 place, including but not limited to repeated failures to follow

1 Centers for Disease Control (CDC) or Occupational Health Safety
2 Administration (OSHA) guidelines;

3 14. Being shown to be mentally unsound;

4 15. Being shown to be grossly immoral and that such condition
5 represents a threat to patient care or treatment;

6 16. Being incompetent to practice dentistry while delivering
7 care to a patient;

8 17. Committing gross negligence in the practice of dentistry;

9 18. Committing repeated acts of negligence in the practice of
10 dentistry;

11 19. Offering to effect or effecting a division of fees, or
12 agreeing to split or divide a fee for dental services with any
13 person, in exchange for the person bringing or referring a patient;

14 20. Being involuntarily committed to an institution for
15 treatment for substance abuse, until recovery or remission;

16 21. Using or attempting to use the services of a dental
17 laboratory or dental laboratory technician without issuing a
18 laboratory prescription, except as provided in subsection C of
19 Section 328.36 of this title;

20 22. Aiding, abetting, or encouraging a dental hygienist
21 employed by the dentist to make use of an oral prophylaxis list, or
22 the calling by telephone or by use of letters transmitted through
23 the mails to solicit patronage from patients formerly served in the
24 office of any dentist formerly employing such hygienist;

1 23. Having more than the equivalent of three full-time dental
2 hygienists for each dentist actively practicing in the same dental
3 office ~~who will supervise the dental hygienists, dental assistants,~~
4 ~~or oral maxillofacial surgery assistants;~~

5 24. Allowing a person not holding a permit or license issued by
6 the Board to assist in the treatment of a patient without having a
7 license or permit issued by the Board;

8 25. Knowingly patronizing or using the services of a dental
9 laboratory or dental laboratory technician who has not complied with
10 the provisions of the State Dental Act and the rules of the Board;

11 26. Authorizing or aiding a dental hygienist, dental assistant,
12 orthodontic assistant, oral maxillofacial surgery assistant, dental
13 laboratory technician, or holder of a permit to operate a dental
14 laboratory to violate any provision of the State Dental Act or the
15 rules of the Board;

16 27. Willfully disclosing confidential information;

17 28. Writing a false, unnecessary, or excessive prescription for
18 any drug or narcotic which is a controlled dangerous substance under
19 either federal or state law;

20 29. Prescribing or administering any drug or treatment without
21 having established a valid dentist-patient relationship;

22 30. Using or administering nitrous oxide gas in a dental office
23 in an inappropriate or unauthorized manner;

24

1 31. Engaging in nonconsensual physical contact with a patient
2 which is sexual in nature, or engaging in a verbal communication
3 which is intended to be sexually demeaning to a patient;

4 32. Practicing dentistry without displaying, at the dentist's
5 primary place of practice, the license issued to the dentist by the
6 Board to practice dentistry and the current renewal certificate;

7 33. Being dishonest in a material way with a patient;

8 34. Failing to retain all patient records for at least ~~three~~
9 ~~(3)~~ seven (7) years from the date of the last treatment, except that
10 the failure to retain records shall not be a violation of the State
11 Dental Act if the dentist shows that the records were lost,
12 destroyed, or removed by another, without the consent of the
13 dentist;

14 35. Failing to retain the dentist's copy of any laboratory
15 prescription for at least three (3) years, except that the failure
16 to retain records shall not be a violation of the State Dental Act
17 if the dentist shows that the records were lost, destroyed, or
18 removed by another, without the consent of the dentist;

19 36. Allowing any corporation, organization, group, person, or
20 other legal entity, except another dentist or a professional entity
21 that is in compliance with the registration requirements of
22 subsection B of Section 328.31 of this title, to direct, control, or
23 interfere with the dentist's clinical judgment. Clinical judgment
24 shall include, but not be limited to, such matters as selection of a

1 course of treatment, control of patient records, policies and
2 decisions relating to pricing, credit, refunds, warranties and
3 advertising, and decisions relating to office personnel and hours of
4 practice. Nothing in this paragraph shall be construed to:

- 5 a. limit a patient's right of informed consent, or
- 6 b. to prohibit insurers, preferred provider organizations
7 and managed care plans from operating pursuant to the
8 applicable provisions of the Oklahoma Insurance Code
9 and the Public Health Code;

10 37. Violating the state dental act of another state resulting
11 in a plea of guilty or nolo contendere, conviction or suspension or
12 revocation of the license of the dentist under the laws of that
13 state;

14 38. Violating or attempting to violate the provisions of the
15 State Dental Act or the rules of the Board, as a principal,
16 accessory or accomplice;

17 39. Failing to comply with the terms and conditions of an order
18 imposing suspension of a license or placement on probation issued
19 pursuant to Section 328.44a of this title; or

20 40. Failing to cooperate during an investigation or providing
21 false information, verbally or in writing, to the Board, the Board's
22 investigator or an agent of the Board.

23 B. The provisions of the State Dental Act shall not be
24 construed to prohibit any dentist from displaying or otherwise

1 advertising that the dentist is also currently licensed, registered,
2 certified, or otherwise credentialed pursuant to the laws of this
3 state or a nationally recognized credentialing board, if authorized
4 by the laws of the state or credentialing board to display or
5 otherwise advertise as a licensed, registered, certified, or
6 credentialed dentist.

7 SECTION 21. AMENDATORY 59 O.S. 2011, Section 328.34, as
8 amended by Section 14, Chapter 405, O.S.L. 2013 (59 O.S. Supp. 2013,
9 Section 328.34), is amended to read as follows:

10 Section 328.34 A. A dental hygienist may practice dental
11 hygiene under the supervision of a dentist in a dental office or
12 treatment facility. A dentist may employ not more than the
13 equivalent of three full-time dental hygienists for each dentist
14 actively practicing in the same dental office. Employing the
15 equivalent of three dental hygienists is employment of any
16 combination of full- or part-time dental hygienists not to exceed
17 one hundred twenty (120) hours per week per dentist.

18 B. 1. A dentist may delegate to a dental hygienist the
19 following procedures:

- 20 a. the duties and expanded duties authorized for dental
21 assistants by the State Dental Act or the rules of the
22 Board of Dentistry,
23 b. health history assessment pertaining to dental
24 hygiene,

- 1 c. dental hygiene examination and the charting of intra-
2 oral and extra-oral conditions, which include
3 periodontal charting, dental charting and classifying
4 occlusion,
5 d. dental hygiene assessment and treatment planning for
6 procedures authorized by the supervisory dentist,
7 e. prophylaxis, which means the removal of any and all
8 calcareous deposits, stains, accretions, or
9 concretions from the supragingival and subgingival
10 surfaces of human teeth, utilizing instrumentation by
11 scaler or periodontal curette on the crown and root
12 surfaces of human teeth, including rotary or power
13 driven instruments. This paragraph shall not be
14 construed to prohibit the use of a rubber ~~cap~~ cup or
15 brush on the crowns of human teeth by a dental
16 assistant who holds a current expanded duty permit for
17 Coronal Polishing/Topical Fluoride issued by the
18 Board,
19 f. periodontal scaling and root planing,
20 g. dental hygiene nutritional and dietary evaluation,
21 h. placement of subgingival prescription drugs for
22 prevention and treatment of periodontal disease,
23 i. soft tissue curettage,
24 j. placement of temporary fillings,

- k. removal of overhanging margins,
- l. dental implant maintenance,
- m. removal of periodontal packs,
- n. polishing of amalgam restorations, and
- o. other procedures authorized by the Board.

2. The procedures specified in subparagraphs b through o of paragraph 1 of this subsection may be performed only by a dentist or a dental hygienist.

3. Except as provided in subsections C and D of this section, the procedures specified in paragraph 1 of this subsection may be performed by a dental hygienist only on a patient of record, which means an individual who has given a medical history and has been examined and accepted by a dentist for dental care, and only under the supervision of a dentist. The level of supervision, whether direct, indirect or general, shall be at the discretion of the supervisory dentist. Authorization for general supervision shall be limited to a maximum of thirteen (13) months following an examination by the supervisory dentist of a patient of record.

C. 1. A dentist may authorize procedures to be performed by a dental hygienist, without complying with the provisions of paragraph 3 of subsection B of this section, if:

- a. the dental hygienist has at least two (2) years experience in the practice of dental hygiene,

1 b. the authorization to perform the procedures is in
2 writing and signed by the dentist, and

3 c. the procedures are performed during an initial visit
4 to a person in a treatment facility.

5 2. The person upon whom the procedures are performed must be
6 referred to the authorizing dentist after completion of the
7 procedures performed pursuant to paragraph 1 of this subsection.

8 3. A dental hygienist shall not perform a second set of
9 procedures on a person pursuant to this subsection until the person
10 has been examined and accepted for dental care by the authorizing
11 dentist.

12 4. The treatment facility in which any procedure is performed
13 by a dental hygienist pursuant to this subsection shall note each
14 such procedure in the medical records of the person upon whom the
15 procedure was performed.

16 D. A treatment facility may employ dental hygienists whose
17 services shall be limited to the examination of teeth and the
18 teaching of dental hygiene or as otherwise authorized by the Board.

19 E. The Board is authorized to:

20 1. Prescribe, by rule, advanced procedures that may be
21 performed by a dental hygienist who has satisfactorily completed a
22 course of study regarding the performance of such procedures. The
23 advance procedures shall include the administration of local
24

12 prohibit a dentist from performing any of the procedures that may be
13 performed by a dental hygienist.

7 G. F. In case of a lost or destroyed license or renewal
8 certificate and upon satisfactory proof of the loss or destruction
9 thereof, the Board may issue a duplicate, charging therefor a fee

12 dental assistant that is in good standing and not under

1 SECTION 26. NEW LAW A new section of law to be codified
2 in the Oklahoma Statutes as Section 328.57 of Title 59, unless there
3 is created a duplication in numbering, reads as follows:

4 A. Beginning January 1, 2015, each dental office operating with
5 a trade name or associated with a professional entity of any name
6 other than the name of a singular licensed dentist shall be required
7 to have a "designated supervising dentist" (DSD). No office shall
8 operate without a designated supervising dentist approved by the
9 Board and upon evidence satisfactory to the Board that:

10 1. The place for which the license is sought shall be conducted
11 in full compliance with the law and rules of the Board;

12 2. The DSD shall verify that all staff members have valid
13 license permits issued by the Board and that the licenses and
14 permits are posted in a conspicuous place within the office;

15 3. The dental office shall have signage on the exterior of the
16 property in public view listing the names of the dentists that
17 practice within the office;

18 4. The DSD shall maintain a log listing the names and license
19 numbers of any dentist working at the dental office along with the
20 dates of services during a calendar year. The log shall be signed
21 by the dentist practicing and the DSD of the dental office. The
22 Board may audit the log as necessary at the dental office. The log
23 shall be maintained for seven (7) years;

24

1 5. A DSD shall be located on the premises at least fifty
2 percent (50%) of the time the dental office is open with the
3 following exceptions:

4 a. a specialist practicing only that specialty may serve
5 as the DSD, not to exceed three offices, and shall be
6 exempted from the fifty-percent-on-premises
7 requirement,

8 b. each office shall be restricted to the specialty
9 practice of the owning specialty dentist,

10 c. if a practice has multiple dentist ownership, one of
11 the practicing dentist owners in the group or
12 partnership shall be designated as the DSD;

13 6. The office shall have written guidelines and procedures for
14 infection-control precautions and procedures required by the State
15 Dental Act and as recommended by the Centers for Disease Control and
16 the Occupational Safety and Health Administration; and

17 7. Other requirements as determined by the Board pursuant to
18 the rules.

19 B. The Board shall have the authority to promulgate rules to
20 enforce this section.

21 C. A trade name dental office found by the Board to be in
22 violation shall be subject to the penalties set forth in Section
23 328.44a of Title 59 of the Oklahoma Statutes and the Board may
24

1 require the dental office to replace the DSD or be subject to
2 closure.

3 D. If the DSD leaves the practice, the Board shall be notified
4 of the new DSD within two (2) working days.

7 Section 328.62 As used in the Oklahoma Dental Mediation Act:

8 1. "Board" means the Board of Dentistry;

9 2. "Dentist" means a ~~graduate of an accredited dental college~~
10 ~~who has been~~ person licensed by the Oklahoma Board of Dentistry to
11 practice dentistry, as defined in Section 328.19 of this title; and

12 3. "Mediation committee" means a committee of persons duly
13 constituted of or appointed by ~~any voluntary dental association,~~
14 ~~voluntary dental society, or the Board~~ a statewide organization
15 representing dentists. The mediation committee shall consist of two
16 members of a statewide organization representing dentists and one
17 former member of the Board not presently serving. The mediation
18 committee is authorized, upon receiving a written request for a
19 review, to conduct a review of the complaints or requests for review
20 of persons, the treatment performed by a dentist and, where
21 appropriate, hold hearings and conduct personal examinations of
22 dental treatment of patients. The mediation committee may, but

- 1 a. evaluate the quality of health care services provided

3 b. determine whether health care services rendered were
4 professionally indicated or were performed in

11 e. recommend to the parties, a method of settlement, for

13 Any decision by the mediation committee not to review a matter shall
14 be communicated by the committee to the affected persons within
15 thirty (30) days after the committee has received the material
16 submitted pursuant to Section 328.65 of this title.

17 SECTION 28. AMENDATORY 59 O.S. 2011, Section 328.63, is
18 amended to read as follows:

19 Section 328.63 A. A mediation conducted through the Oklahoma
20 Dental Mediation Act is voluntary and shall not be considered a
21 final action for the purposes of injunctive relief or the basis for
22 an appeal to district court. A mediation committee, entities
23 creating such mediation committees, members and staff of such
24 mediation committee, and other persons who assist such mediation

1 committees shall not be liable in any way for damages or injunctive
2 relief under any law of this state with respect to any action taken
3 in good faith by such mediation committee.

4 B. Any person who supplies information to a mediation committee
5 in good faith and with reasonable belief that such information is
6 true shall not be liable in any way for damages or injunctive relief
7 under any law of this state with respect to giving such information
8 to the mediation committee.

9 C. Either party involved in the mediation may request to be
10 dismissed from the process at any time. Upon dismissal from the
11 mediation program, the matter shall be referred back to the
12 referring entity.

13 D. Upon the completion of a successful mediation, the referring
14 entity shall be given notice that the mediation was successful.

15 SECTION 29. This act shall become effective July 1, 2014.

16 SECTION 30. It being immediately necessary for the preservation
17 of the public peace, health and safety, an emergency is hereby
18 declared to exist, by reason whereof this act shall take effect and
19 be in full force from and after its passage and approval.
