

Facility Specific Criteria

1. Bill Johnson Correctional Center

No sex related convictions past or present (exceptions as approved by the administrator of Classification and Population)

Ages 18 to 40

Sentence Length:

- a. 15 years non violent
- b. 10 years violent
- c. 7 years for those with trafficking convictions and classified as non-violent
- d. No less than 3 years to serve or remaining to serve, unless court ordered, or with a parole stipulation

These criteria do not apply to offenders with delayed sentences or offenders placed at BJCC for their general population unit

Offenders must meet the Health Services placement criteria.

2. Clara Waters Community Corrections Center

Offenders having any conviction for a violent offense will not be eligible

3. Contract County Jails

No Murder I or II past or present

No escape from medium or maximum, past or present

No overrides maximum to medium except to Oklahoma County

Overrides from medium to minimum must have current non-violent and minimum at first review.

No sex offenders convicted in Oklahoma County to Oklahoma County

No one age 17 or younger

4. Earl A. Davis Work Center

Not having ever been convicted of Manslaughter I, or crimes involving minor children

Not having ever been arrested for a sex offense regardless of the outcome

Not having any felony convictions in Hughes County

5. Enid Community Corrections Center

Offenders currently serving a violent offense will not be eligible.

May not have more than one prior conviction for a violent crime or deemed dangerous, assaultive or violent.

6. James Crabtree Correctional Center

No younger than 35 years of age for medium security

No younger than 25 years of age for minimum security

Transfers from maximum security must be approved by Deputy Director of Institutions, Division III

No Battery on Staff (04-8) in the last 12 months

7. Kate Barnard Community Corrections Center

No offender who is deemed dangerous or violent by the department classification committee.

8. Northeast Oklahoma Correctional Center

No sex related convictions, past or present

No escapes from higher security in the last ten years

9. Oklahoma State Reformatory

No younger than 40 years of age for medium security

10. Private Prisons

No one 17 years old or younger

11. William S. Key Correctional Center

No sex related convictions

No escapes from higher security within the past 10 years

No violent offender that will cause, or has caused, adverse publicity in that area of the state
