

### **Criteria For Offering Modifications Form**

The granting of a request for a Modified Driver's License is discretionary with the Department. When the department considers any request for a Modified Driver's License where the person have been given a Notice of Revocation stemming from an arrest for Driving Under the Influence or an arrest for Being In Actual Physical Control of a Motor Vehicle, the Department will ask the person requesting the Modified Driver's License to answer "Yes" or "No" as to whether or not their arrest involved any of the situations set forth on the "**Criteria For Offering Modification**" form.

If a person's arrest involved any of the set forth situations on the form, then it is likely that the Department will **not** be agreeable to granting the person a Modified Driver's License.

If a person is **denied** a Modified Driver's License by the Department, the person may appeal that decision to the district courts as provided under 47 O.S. Section 6-211.

In addition to completing the "**Criteria For Offering Modification**" form, the person seeking a Modified Driver's License will also have to complete an "**Information For Modified Driver's License**" form as part of the application process.
