LEGISLATIVE REFERENDUM NO. 22

Submitted by House Joint Resolution No. 2, page 722, Session Laws 1913.

The gist of the proposition is as follows:

To amend the Constitution of the State, so that the Legislature shall have power to levy taxes in aid of the common schools of the State, and to provide for the apportionment and distribution thereof among those school districts of the State in which a ten mill ad valorem levy and money derived from all other sources is sufficient to maintain common schools for five months in a year, giving to such districts out of said fund hereby authorized, such additional sum as is necessary to maintain schools therein five months in each year.

In providing (1) Amendment to present methods of assessment levy and appeals, exempt bonds of State and its municipalities from ad valors tax; (2) Methods of taxation of banks both state and national, effective prior to May 16, 1913.; (3) Mining property tax law, raising rate on oil production tax to ten mills; (4) Taxation of certain transmission companies according to gross receipts only; (5) Graduated tax on land holdings exceeding six hundred and forty acres and of value exceeding ten thousand dollars.
