

AGENDA FOR OKLAHOMA STATE ELECTION BOARD MEETING

As required by Title 25 of the Oklahoma Statutes, § 311, notice is hereby given that the Oklahoma State Election Board will hold a **Regular** meeting, **April 25, 2016, at 9:00 a.m.**

The meeting will convene in **Room B-6**, State Capitol Building, Oklahoma City, Oklahoma, for consideration of Agenda items 1 and 2. The meeting will then recess, move to, and reconvene at **9:30 a.m. in Room 230, Second floor, Senate wing (North Hall)**, State Capitol Building, Oklahoma City, Oklahoma, to hear the Contests of Candidacy identified in Agenda items 5 through 25.

The Board may discuss, Vote to Approve, Vote to Disapprove, or take other action on any item listed on this Agenda. The Board may take Agenda items 5 through 25 in any order it deems appropriate.
