PETITION FOR CONTEST OF CANDIDACY


Candidate Monroe Nichols for the office of State Representative for House District 72, having lawfully filed a Declaration of Candidacy during the filing period held on April 8, 9, and 10, 2020, here by contests the candidacy of Ismail Shan (hereinafter referred to as "Contestee") for the same office, pursuant to 26 O.S. 2011, § 5-118 of the Oklahoma Statutes, and as a basis for this contest, states and alleges as follows:

1. Contestee was not qualified by law to become a candidate for the office at the time he filed a Declaration of Candidacy.
2. Contestee does not meet the residency requirements to file as a candidate for the House of Representatives as provided in Title 14 Oklahoma Chapter 3, Section 108 of the Oklahoma Statutes, in that he has not been a resident residing within House District 72 for at least six (6) months immediately preceding the filing period prescribed by law.

WHEREFORE, Petitioner requests that the State Election Board strike the candidacy of Contestee and order that his name not be placed on the ballot for the reasons set forth above.




