The Democratic National Convention will be conducted, in part, by remote voting in accordance with Democratic Party rules, from August 3 through August 15, 2020; and will involve live programming, including the announcement of the foregoing nominations, in Milwaukee, Wisconsin and other satellite locations from August 17 through August 20, 2020.

Vice President Biden has earned more pledged delegates than are required under party rules to obtain the Democratic Party's nomination, and more than the required number have already cast their remote Convention ballots in support of his candidacy. He therefore will be the nominee of the Democratic Party for President of the United States. Furthermore, on August 12, 2020, Vice President Biden


