Ms. Turpen seconded the motion. **ROLL CALL VOTE:** Mr. Prince-aye; Ms. Turpen-aye; Mr. Watkins-aye. Motion passed, 3-0. (Nomination list attached)

9. **BUSINESS CONDUCTED:** Consideration and action regarding the retirement of the secretaries of the Kay County Election Board and the McCurtain County Election Board. **ACTION TAKEN:** The Board acknowledged the retirement of Carol D. Kellum as the Secretary of the Kay County Election Board and Lue Davis of the McCurtain County Election Board, effective May 31, 2011. (Notice of Retirements attached)

10. **BUSINESS CONDUCTED:** Consideration and action regarding the appointment of the secretaries of the Kay County Election Board and the McCurtain County Election Board. **ACTION TAKEN:** Mr. Watkins moved to appoint Cheryl Howard as the Secretary of the Kay County Election Board and Kelly K.
