

## MINUTES

### OF THE STATE ELECTION BOARD AT ITS MEETING

April 10, 2012

The State Election Board met in a Special meeting at 5:00 p.m. in Room 419-A of the State Capitol Building. Advance notice of the meeting was performed by filing a written notice with the Secretary of State on February 16, 2012, at 9:47 a.m. A copy of the agenda is attached.
