Lobbyists who register as both Executive Lobbyists and Legislative Lobbyists will default to the Legislative Lobbyist reporting schedule. If a lobbyist prefers to file executive expenditures on the executive lobbyist reporting schedule and legislative expenditures on the legislative lobbyist reporting schedule the lobbyist will need to file two registrations—one as an executive lobbyist and one as a legislative lobbyist.
