Committees Only. This calendar is for State Question Committees only.

Non-Committees: Entities that are not required to register or file reports as a committee will not use this calendar but the **State Question Communication Non-Committee Reporting Calendar**.

STATE QUESTION COMMITTEE REPORTS

Quarterly Reporting Required of ALL SQ Committees. Quarterly Reports of Contributions & Expenditures are required until the committee is dissolved in accordance with the Ethics Rules.

Additional Reports may be required during the final two weeks prior to an election, see the “**Additional Reports Required**” section below.

*Unlimited SQ committees that do not (1) file a final report by Dec. 31st and (2) dissolve as required in the Ethics Rules are required to renew their registration, including payment of Registration Fees.

ADDITIONAL REPORTS REQUIRED

Pre-Election Reports Required: SQ committees that make State Question Communications (“SQC”) *more than* two (2) weeks prior to an election totaling \$5,000 or more are required to make Pre-Election Reports during the same timeframes candidates file pre-election reports, as shown below.

Next Business Day Reporting Required. SQ Committees that make SQCs *during the final two weeks* prior to an election must file reports not later than the next business day as follows.

- **1st Report:** Due not later than the Next Business Day once \$5,000 or more is reached or exceeded.
- **2nd and Subsequent Reports:** Due not later than the Next Business Day for all additional SQC expenditures *regardless of value*.
