2024: State Political Party Committee Reporting

Local Party Committees: County, congressional district and other non-state committees will use the local party committee calendar. All state party committees will file reports on a quarterly basis and pay the registration/renewal fee annually in July. State political party committees will file a current Statement of Organization in July of odd-numbered years. During election years, if the committee makes independent expenditures and electioneering communications, the committee may also need to file pre-election reports detailing independent expenditures and electioneering communications.

2024 Elections: Independent Expenditures & Electioneering Communications

Committees that expend a total of \$5,000 or more on independent expenditures or electioneering communications must file preelection reports detailing the expenditures according to the calendar below.

INDEPENDENT EXPENDITURES & ELECTIONEERING COMMUNICATIONS REPORTS

The reports below will be triggered when making Independent Expenditures or Electioneering Communications of \$5,000 or more in the aggregate prior to an election.

*Once the \$5,000 threshold is met during a pre-election reporting period, all additional IEs/ECs must be reported regardless of the amount.
