The question was raised whether the target population for the third goal should include all health professionals as well as continuing education for all health professionals. The following changes were made to the draft:

GOAL: Health care professionals will have resources available to address barriers to effective patient communication including literacy and English competency. Health literacy efforts must target:


- ~~Medical education~~ ALL health professionals
