



WASHINGTON , March 22/PRNewsWire/ — The Federal Interagency Coordinating Committee for the Prevention of Underage Drinking, chaired by the Substance Abuse and Mental Health Services Administration (SAMHSA), in partnership with state and local agencies and organizations, is spearheading a nationwide campaign to curb underage drinking before it starts. Town hall meetings, with the theme “Start talking before they start drinking,” are being convened on and around March 28, 2006, in approximately 1,200 communities across the country.

In over 2 dozen rural and urban Oklahoma communities, residents will come together to learn more about the latest research on the impact of underage drinking on both individuals and the community, and to discuss how their community can best prevent underage alcohol use by reducing demand, availability and access. Oklahoma governor Brad Henry, who has proclaimed March 28, 2006, as underage drinking prevention day in the state, and first lady Kim Henry will be participating in a number of town hall meetings. Other state and local officials, parents and youth will join community leaders and organizations (spanning health, education, law enforcement, highway safety, and alcohol control) across the state to encourage parents to talk with their children early and often about the negative effects of alcohol.

Research shows that parents of teens generally underestimate the extent of alcohol used by youth and its negative consequences, with parents viewing underage drinking as “inevitable.” According to the 2004 National Survey on Drug Use and Health, roughly 10.8 million underage persons ages 12 to 20 (28.7 percent) reported current alcohol use. Of these underage drinkers, 4.4 million were ages 12-17. Approximately 11.1 percent of 12-year-olds reported using alcohol at least once in their lifetimes. By age 13 the percentage doubles, and by age 15 it is over 50 percent. Teens use alcohol more frequently than all illicit drugs combined. In addition to its negative impact on health, alcohol use among youth is strongly correlated with violence, risky sexual behavior, poor academic performance, alcohol-related driving incidents, and other harmful behaviors. In fact, alcohol is responsible for six times the number of youth deaths than can be attributed to all other drugs combined.

The town hall meetings will feature released public service announcements, developed in collaboration with the Ad Council, that bear the theme “Start talking before they start drinking.” Other first ladies will participate in town hall meetings in Florida, Maine, New Mexico, North Carolina, Ohio and Wyoming.
