Medicaid-Only Provider Relief Portal link *CORRECTED*

HHS expects to distribute approximately \$15 billion to eligible providers that participate in state Medicaid and CHIP programs and have not received a payment from the Provider Relief Fund General Distribution and \$10 billion to safety net hospitals. This would appear to apply to ICF/IID facilities and advantage waiver assisted living centers. The payment to each provider will be at least 2 percent of reported gross revenue from patient care; the final amount each provider receives will be determined after the data is submitted, including information about the number of Medicaid patients providers serve.
