Dear EMS Administrator:

Application for reimbursement from the upcoming Trauma Care Assistance Revolving Fund (OAC 310:669) is for the claim period **July 1, 2015 through December 31, 2015**. Each licensed service filing a claim for reimbursement of uncompensated expenses for trauma care must submit a complete application package (refer to the *Checklist for Submission* for items required).

Attached is a list of cases based upon the information you submitted to the State EMS Data System, OKEMSIS. These are potential cases and have **NOT** been confirmed for Trauma Fund eligibility. Only cases that meet both Trauma Fund clinical and financial criteria are eligible for Trauma Fund reimbursement. **Please compare this list with the Trauma Fund EMS criteria to determine cases for submission, and ensure that the case(s) are uncompensated.** Please submit only cases that meet the Trauma Fund criteria. Cases that do not meet the criteria slow the process and delay reimbursement.

*IF YOU DID NOT RECEIVE AN ATTACHMENT, YOU CAN STILL APPLY. Absence of an attachment indicates that specific data elements were not retrievable from OKEMSIS for various reasons. A complete application with all items listed in the Checklist for Submission must be received in the OSDH-Emergency Systems office by **5:00 P.M. on Thursday, December 15, 2016.***

Any incomplete, inaccurate or late application will be automatically disqualified for reimbursement from the Trauma Fund.
