SPECIFICATIONS:

1. The contractor shall collect, remove from Oklahoma State Dept. of Health property, and property incinerate all "biomedical waste" generated by the Public Health Laboratory. Incineration shall be in accordance with all applicable federal, state and municipal regulations, laws and ordinances in an incinerator that is approved by the locality in which it is situated for the incineration of biomedical waste as defined below and Oklahoma State Dept of Health Regulations Governing Solid Waste and Sledge Management, Chapter Eight.
2. Biomedical waste shall include those wastes defined by the United States Environmental Protection Agency as infectious Wastes and any other waste identified as infectious or similar waste in any other applicable federal, state, county or municipal laws, regulations, or guidelines.
3. Pickup shall be on a schedule mutually to both parties, but not less than three (3) times weekly, and shall be at a site designated by the Oklahoma State Dept. of Health.
4. The containers provided for the collection and transportation of biomedical waste products shall conform in all respects to all federal, state and local requirements.
 - A. Containers shall be constructed of cardboard or fiberboard of no less than two hundred pounds (200 lb.) test with a "B" flute and moisture resistant adhesive.
 - B. Containers shall have minimum dimensions of 17 7/8" x 14 7/8" x 20 7/8".
 - C. Containers shall have a positive locking feature when closed and shall also have lifting handles formed as an integral part of the container.
 - D. The containers shall have the international biohazard symbol printed on each side in RED.
5. Two liners shall be provided with each container.
 - A. Liners are to be RED in color and be constructed of plastic not less than two (2) mils in thickness.
 - B. Liners shall be of the thirty (30) gallon size.
6. The collector shall assume title to all biomedical waste collected from the Public Health Laboratory and shall hold the Oklahoma State Department of Health and the State of Oklahoma

7. The contractor will provide all equipment and supplies necessary to provide the services described above. All equipment and supplies will conform in all respects to all applicable federal, state, county and municipal laws or regulations pertaining to the collection and disposal of biomedical waste products.

8. The contractor will obtain, keep current, and provide copies to the Public Health Laboratory of all necessary licenses, permits, and other documents which may be required by the federal, state, county or municipal jurisdiction. A copy of the permit to operate for any and all incinerators to be used must be furnished with bid.

9. The contractor shall maintain for the duration and purpose of the agreement and will provide proof of the same with bid:

- A. Worker's Compensation
- B. Employer's Liability - \$1000,000 each occurrence.
- C. Comprehensive General Liability, including contractual liability \$100,000 each occurrence.
- D. Comprehensive Automobile Liability \$100,000 each occurrence.

10. Current certificates of insurance will be provided to the Public Health Laboratory on request.

11. The contractor will indemnify and hold Okla. State Dept. of Health harmless from any and all loss, damages, suits, penalties, cost, liabilities and expenses arising out of any claim for loss or damage to property of Oklahoma State Dept. of Health employees caused by or resulting from the contractor's negligence or willful misconduct or breach of agreement.

12. The contractor will comply with all applicable laws, regulations, and rules regarding documentation of transportation and disposal of biomedical waste, and will provide the Public Health Laboratory with certificate of incineration of all waste products accepted by the contractor.

13. The price bid by the contractor shall be expressed on a per pound basis and shall include all pickup, transportation, and incineration by the Public Health Laboratory and all equipment and supplies necessary to accomplish same.

14. A billing receipt of each waste pickup must be signed by the Public Health Laboratory Quality Control/Safety Officer or his designated representative.
