Special Update:

Review of the Home Visiting Outcomes Measurement Plan: Submitted to the Governor and Legislature.

Debra Andersen and Sarah Ashmore: Smart Start Oklahoma

- The Outcomes Measurement Plan reflected the benefits of Home Visitation services and the outcomes being accomplished for the State of Oklahoma.
- Was conducted to the Bill that was passed spring 2015.
- Information gathered for the plan was from feedback from stakeholder meetings that home visitors were able to give their suggestions and concerns.
- Categories were chosen by legislation and they include: Preterm Birth Rates, Parental Substance Abuse, Parental Tobacco Use, Interbirth Interval, Reported Child Abuse and Neglect, Substantiated Child Abuse and Neglect, Maternal Depression, Domestic Violence, Parental Employment, Parental Education Attainment, and Developmental Milestones
- 5 Year plan: If measures aren't meeting standards they will be revised prior to the ending of the 5 years.
- Benchmarks weren't included due to short time frame and some programs didn't have data in place.
- Beginning July 1, 2016 Benchmarks may be included.
- Annual Report is due December 31, 2017.
- Data Collection will begin July 1, 2016.
- There is not an expectation that all programs collect all the same data. The plan was designed to include the state as a whole.
- The plan will not be comparing program models, just focuses on the accountability.
- Enhancing programs due to lack of accountability is the plan by providing continued education and resource; not closing facilities.
- The plan is in place to make sure programs stay on track and that the state dollars are used appropriately.
- Ways we can help:
 - Collect good data;
 - Turn data in timely;
 - Feedback that will help make it a seamless process; and
 - Talk to your Legislators.

**Oklahoma Professional Development Registry: Professional Development Collaborative --
What it means for you?**

***Jill Soto -- Assistant Director and Teri Clark -- Data Systems Administrator:
Center for Early Childhood Professional Development***

- The registry is a data system which began operation in 2012 in the child care industry for the past five years
- Program was awarded a Grant with MCH to work with client's birth to age eight.
- Gives you the ability to track ones professional development and certificates on a state and county level.
- Program is partnered with Child Guidance and SoonerStart at this time.
- To participate one can register by June 1, 2016 to get the \$10 annual fee waived.
- The consecutive years will be paid for by their respective agency.
- Three benefits of registry:
 1. Training Calendar: a training calendar will be created so that agencies can attend trainings that they need if another state agency is offering them.
 2. State Wide: trainings will be available state-wide for all agencies to utilize.
 3. Increase trainings: allows more opportunities for agencies to attend trainings that they may not be able to offer their employees.
- Calendars:
 - Participants Only: trainings are provided but closed to others that are not in that specific agency.
 - Open to all Agencies: trainings hosted by one agency but open so other agencies can attend.
- Grant Information:

 - Year 1: Building the grant.
