

Oklahoma Achieves Excellence

The OCCR received notification of gold certification from the North American Association of Central Cancer Registries (NAACCR) for its annual Call for Data submitted in November 2015. The submission included data from 1997-2013 and was evaluated for completeness of case ascertainment, quality of the data and timeliness. OCCR achieved the gold standard with 100% passing edits, 94.4% completeness, less than 1% missing data elements for sex, age, county and race, and less than 3% death certificate only cases.

The OCCR also received two awards from the National Program of Cancer Registries (NPCR) which designated the registry as a “U.S. Cancer Statistics Registry for Surveillance” and a “2015 Registry of Distinction.”

OCCR is pleased to have been recognized by both NAACCR and NPCR. We wish to thank all of our reporting facilities for their role played through submission of timely and quality cancer data.



OCCR Case Collection Update

Originally, OCCR anticipated the conversion of our database to NAACCR version 16 would take place in June to early July. However, due to the delayed release of the version 16 metafile from NAACCR, the conversion is expected to take place in September 2016. If your facility has started abstracting 2016 diagnosed cases, please continue to hold those cases in suspense until our database has been converted. OCCR will notify all facilities when the conversion is complete and we are ready to accept 2016 cases.

If your facility is still abstracting 2015 cases, please attempt to submit all 2015 diagnosed cases to the OCCR before converting your system to version 16. This will help to ensure that all of your 2015 cases are current and accounted for in the OCCR database.

NOTE: Any facilities still in version 14 must convert their system to version 15 immediately. Version 14 files will be very difficult to submit once OCCR converts to version 16. Please contact your facility consultant if you need assistance.

Text Documentation of Tumor, Nodes, Metastasis (TNM) Fields

One of the new requirements for reportable cases diagnosed in 2016 is the completion of the TNM fields. The OCCR would like to reiterate that with the transition to TNM staging, it is very important that registrars provide specific text documentation to support coding. The OCCR receives information from multiple reporting sources and consolidation is performed before submission to our standard setters. If there is a discrepancy in codes from separate facilities, the text fields are reviewed to determine and/or confirm accurate coding. Supportive text simplifies the consolidation process and increases our confidence in providing accurate staging data. The Text-Staging field provides an area for documenting staging information not already entered in other text fields. It is suggested that registrars record BOTH clinical and pathological staging in this field. Please see below for examples of accurate text documentation of TNM staging criteria in the Text-Staging field.

Text – Staging

Clinical: T1 N0 M0 Stage IA Pathologic: T2 N1 M0 Stage IIB

cT1 cN0 cM0 IA, pT2 pN1 pM0 IIB



Did You Know?

Cancer data, including demographics, methods of diagnosis, treatment protocols, and survival outcomes, are used for cancer incidence surveillance and other research projects. Have you ever wondered how the information that you submit to OCCR is being used? The following are just a few examples:

- ◆ “Public Health in Action” is a report in which cancer data was provided as an initiative to inform Oklahoma leadership about the burden of cancer in Oklahoma.
- ◆ “[OKStateStat](#)” is a website designed under the leadership of Governor Mary Fallin to track the progress of chronic disease prevention and health prevention programs.
- ◆ The Management, Leadership and Coordination (MLC) team in partnership with the American Cancer Society (ACS), hosted a roundtable event in Lawton, OK. The event was designed to integrate community members and healthcare providers to discuss colorectal cancer and state funded colorectal cancer screening.
- ◆ A Cancer High Need Map was developed to identify geographic locations in need of breast and cervical cancer screening services.
- ◆ At an evidence-based public health training to 44 participants, cancer data was used for case studies. The training was a train the trainer program provided through the Brown School of Public Health in St. Louis, MO.
- ◆ Cancer data was used to develop the first draft of the “Oklahoma Cancer State Plan (2016-2020).” The anticipated release of the final version of the plan will be October, 2016.



NAACCR CTR Exam Preparation and Review
