Hospitals – 44; CMHC 168, FQHCs 36+, Health Departments 108, Corrections, 22+, HIS 33+. There is no precise way to measure the number of sites. New 501(c)3 will create mechanism for more accurate count and identification of sites.</p>	<p>9/2013 “Telehealth Alliance of Oklahoma” has now been approved as an office 501(c)3 organization.</p> <p>6/2013 Goal has been satisfied but work is ongoing. Work to establish “The Telehealth Alliance of Oklahoma” continues. Regular stakeholder meetings are being held. OHIP members are encouraged to attend.</p> <p>3/7/2013 Heartland Telehealth Resource Center (previously erroneously referred to in OHIP reports as “OUHSC Center for Telemedicine”) has received grant approval for another four years. The 501(c) 3 will be formed by end of April, named “The Telehealth Alliance of Oklahoma” and will include representatives from a full spectrum of health organizations and advocates.</p> <p>12/7/2012 OUHSC Center for Telemedicine is establishing a 501(c)6 organization to advance effective use of telehealth services through Oklahoma. (Presentation attached.)</p> <p>9/7/12 Update provided by Cynthia Scheideman-Miller. OUSCH continues to work on establishing a statewide partnership that will incorporate a wide range of stakeholders. Objectives are under development; will include central clearing house and an easier credentialing process. There are now 500 telemedicine sites.</p> <p>6/7/2012 Update provided by Dr. Ben Pettit, OSU Center for Rural Health. OSU continues work with OSU Medical Center to assist physicians in the use of office based telemedicine. Following areas have expressed interest: Urology, ENT, Cardiology, and Orthopedic Surgery. Tentative plans for “office based demonstration” using mobile telemedicine clinic as the distant site for some physicians on the 25th of June; Continue to work on the finalization of internal policy and procedures with a due date of June 30th; Assisting medical leadership of Phillips 66 in Bartlesville to help evaluate the use of telemedicine from Houston to Bartlesville; Have begun to explore the development of a “fee for equipment and network” fashioned after Georgia’s program.</p>

Done 	<p>6/2013 Heartland continues to work to expand telemedicine in Oklahoma. Currently in progress of enforcing rules regarding "Universal Service" connections to ensure appropriate strength is available for telemedicine infrastructure.</p> <p>3/7/2013 Heartland Telehealth Resource Center submitted comments on the OHCA proposed rules for telemedicine. Center will continue to work with OHCA to ensure rules do not present barriers to access. Providers and patients gave feedback on proposed rules. There is still too much inconsistency in definition of telehealth sites and services; comments included recommendations to ensure consistency. Comments also included requests to align Medicaid and Medicare definitions, services and rules.</p> <p>Center is working with Federal and State level government to assess financial impact, using evidence-based outcomes as a guide.</p> <p>A Telemedicine/Telehealth focus group is being organized by OUHSC (facilitated by Georgia group). Key stakeholders are requesting a more organized group to address policy issues and form a formal consortium. (See minutes for details.) Conference is being planned October 29-30 at Sami's Education Center in Children's Hospital.</p> <p>For 2013, College of Nursing has approved the incorporation of technology, safety & quality improvement into nursing into core curriculum; As part of a grant proposal, content will be developed for interprofessional teams.</p>

Office of Primary Care will complete statewide assessment of health professional shortage areas September 30, 2013. Update from Rick Ernest: Workforce Center has been unable to provide data. Workgroup will form new data committee to establish benchmarks, collect data, and complete assessments. 12/7/12 1) Databook has incorporated elements as suggested by workgroup members including mental health practitioners and the addition of benchmark indicators of health professional shortages. 2) OSU Center for Rural Health Policy has received funding from state legislature to create and run a rural residency program. First family medicine residency program will begin in McAlester. Others to be developed this year. 9-7-12 OSU Office of Rural Health Policy and Research and Oklahoma Employment Security Commission have both presented new methods of gathering and collecting data. A "Oklahoma Healthcare Workforce Databook" will be created. Members are submitting data elements and sources of data. Update from Candace Shaw: No word on grant, yet, but they are still under consideration No timeline available. 9-7-12 Did not receive grant.</p>
