### TRAUMA FUND RECIPIENT AUDIT 2015

Oklahoma State Department of Health (OSDH) has contracted with **Muret CPA, PLLC\*** to conduct a compliance review of the state's Trauma Care Assistance Revolving Fund ("the Fund"). This review is being conducted in accordance with our fiduciary responsibilities as managers of this Fund.

**Muret CPA, PLLC** will identify a sample of providers who received reimbursement from the Trauma Fund for care provided from **January 1, 2011 to December 31, 2011**. A random sample of claims from the selected provider will then be identified to be reviewed for compliance with the requirements contained in *Chapter 669 Trauma Care Assistance Revolving Fund*. Providers who have been selected to be part of the audit will receive further communication in the upcoming weeks, from **Muret CPA, PLLC** with instructions regarding:

- Audit process
- Specific sample of identified claims
- Associated documentation that will be necessary to support those claims.

Please be assured that OSDH and **Muret CPA, PLLC** have confidentiality agreements in place, and that **Muret CPA, PLLC** is authorized to review documentation that includes Protected Health Information during the review. OSDH and **Muret CPA, PLLC** take the safety and security of personally identifiable health information very seriously, and will work together to ensure that all appropriate safeguards are in place through the course of this audit.
