

**Buffy Heater, MPH**

Strategy Officer to the Oklahoma Health and Human Services (HHS) Cabinet
Oklahoma State Department of Health

Mrs. Heater, originally from northeastern Oklahoma, received her undergraduate degree from Northeastern State University before receiving her Master's degree in Public Health Administration and Policy from the University of Oklahoma Health Sciences Center. Mrs. Heater joined the Health Care Authority in August 2002, after leading numerous community-based projects for the Community Action Resource & Development Agency in Bartlesville.

In her previous role for OHCA as Chief Strategy Officer, Mrs. Heater was responsible for overseeing the planning and development of projects complementing the agency's vision and strategic plan. She oversaw the OHCA's Central Portfolio and Project Management Office ensuring visibility, coordination, and measurement of project outcomes, as well as appropriate resource allocation and validation of portfolio alignment with agency and statewide goals. Additionally, annual reporting of the OHCA's strategic planning activities as well as core functional efforts were completed under her direction.

In July of 2016, Mrs. Heater was assigned to a detail as Strategy Officer to the Oklahoma HHS Cabinet. In this current role she aligns and coordinates the development of multiple waiver programs and projects across four HHS cabinet agencies: Oklahoma Health Care Authority, Oklahoma State Department of Health, Oklahoma Department of Mental Health and Substance Abuse Services and Oklahoma Department of Human Services. She led Oklahoma's policy development to encourage and streamline work and training support programs across public agencies; and also led the state's Section 1332 Waiver development efforts, aimed at improving and stabilizing the individual health insurance market for consumers purchasing coverage through the ACA-established Marketplace.

She and her husband Tobey, an Environmental Consultant with Oklahoma Environmental Services (OES), have been married for 18 years and currently live in Oklahoma City where they are raising their four young daughters.

As a Professor in the Department of Biostatistics and Epidemiology at the University of Oklahoma Health Sciences Center, Dr. Laura Beebe has more than 18 years of experience conducting tobacco-related research and evaluation. Dr. Beebe has served as the Principal Investigator for the evaluation of Oklahoma's tobacco control program for more than 14 years, including the evaluation of the Oklahoma Tobacco Helpline and the state's anti-tobacco health communications campaign. Dr. Beebe has ongoing and completed research funded by the National Cancer Institute, the American Legacy Foundation, and the CDC. She provides technical assistance and consultation to multiple state, local, and tribal organizations for tobacco-related surveillance and evaluation activities.
