Description of Amendment:

Questions and Answers:
1. Is electronic submission acceptable (A.2.4 Bid Submission) Electronic copy must be a CD only. For this solicitation, OSDH is not requiring an electronic submission. See "Instructions to Suppliers".
2. What is the difference between "lowest and best" bid and "best value" bid? This solicitation is for best value.
"Lowest and best" means an acquisition based on criteria which include, but are not limited to, the following:
a. the lowest total purchase price,
b. the quality and reliability of the product, and
c. the consistency of the proposed acquisition with the state agency's planning documents and announced strategic program direction;
"Best value criteria" means evaluation criteria which may include, but is not limited to, the following:
a. the acquisition's operational cost a state agency would incur,
b. the quality of the acquisition, or its technical competency,
c. the reliability of the bidder's delivery and implementation schedules,
d. the acquisition's facilitation of data transfer and systems integration,

- e. the acquisition's warranties and guarantees and the bidder's return policy,
- f. the bidder's financial stability,
- g. the acquisition's adherence to the state agency's planning documents and announced strategic program direction,
- h. the bidder's industry and program experience and record of successful past performance with acquisitions of similar scope and complexity,
- i. the anticipated acceptance by user groups, and
- j. the acquisition's use of proven development methodology, and innovative use of current technologies that lead to quality results;

3. When is expected start date? December 1, 2015

4. Is there a budget template available or is the budget in E.9 where costs are divided equally by the 3 milestones required only? It is not clear whether a detail budget would be included in the work plan where resources and phases are outlined. What budget detail is required? There is no required budget template to complete, but budget must be addressed, at a minimum, by three milestones as outlined in C.3 and E.9 of the proposal.

5. Have the MCH projects been identified? If so, can you provide a brief description? Are the projects statewide? With hospitals, practices? Is there current central oversight by OSDH for these quality improvement projects? Is the implementation of the quality improvement projects funded by OSDH or are these projects supported by hospitals and practices? The MCH quality improvement projects will be identified upon award of bid, and will be related to reducing infant mortality and improving birth outcomes and equity in Oklahoma. There is central oversight by the OSDH for the implementation of these quality improvement projects. Additionally, said projects are funded, at least in large part, by the OSDH through grant and other funding received. These projects can include various partners, including but not limited to, hospitals and practices.

6. If the MCH projects require data collection at the hospital or practice level, will OSDH be providing the data collection resources? Yes, hospital discharge and other related data collected via existing data systems can be provided.
