The Oklahoma Accountancy Board (OAB) convened in regular session on Friday, September 20, 2019, at the Webb Building, Northeastern State University, 610 N Grand Avenue, Tahlequah, OK 77464. A recording of the meeting is on file in the OAB office. Members present at Call to Order:

**Agenda Item #1a – Call To Order:** At approximately 9:01 AM, Chair Vernon called the meeting to order.

**Agenda Item #1b – Declaration of Quorum:** Chair Vernon declared a quorum.

**Agenda Item #1c – Announcement of Legal Meeting Notice:** Executive Director Ross confirmed the notice of the meeting was filed with the Secretary of State and the agenda for the meeting was properly posted in compliance with the Open Meeting Act.

**Agenda Item #1d – Announcement of Absences and Action, if Necessary, to Determine Whether Absence(s) Were Unavoidable Pursuant to Title 59, Section 15.3(B)(5):** Secretary Sanner was absent. Chair Vernon excused his absence.

**Agenda Item #2 – Announcement of Visitors:** The following visitors were present for the appropriate time: Steve Milam, representing the OSCP; Elizabeth Millen, representing the OSA; Dr. John Uzzo; Dr. Brian Jackson and Anthony Riggs representing Northeastern State University; and various Northeastern State University students.

**Agenda Item #3 – Public Comment Period:** Executive Director Ross advised the Board that he had not received any requests for public comment.

**Agenda Item #4 – Consent Agenda:** The Consent Agenda contained four items for the OAB's consideration: (1) Approve the Minutes of the August 2, 2019, Regular Meeting of the OAB; (2) Take official notice of the preliminary OAB financial statements for FY 2020, for the months ending July 31, 2019 and August 31, 2019; (3) Take official notice of the experience verification applications which have been approved by the Executive

Director and; (4) Approve the actions taken by the Executive Director on applications and registrations filed since the previous meeting.

Motion by Manning that the Board approve the Consent Agenda. Second by Taylor.

**Agenda Item #5 – Oklahoma Accountancy Board student presentation:** Chair Vernon, Assistant Attorney General John Crittenden and Executive Director Ross gave the student presentation.

**Agenda Item #6 – Discussion and possible action on Administrative Actions and recommendations and report from the Enforcement Committee:**

#### **ADMINISTRATIVE CONSENT ORDERS:**

##### **Case No. 2227 – Ralph B. Richey, CPA**

This case was opened as a result of a referral by the CPE Coordinator that Respondent was two hours short of meeting four-hour minimum ethics CPE requirement for compliance period 2015-2017. An Administrative Consent Order was offered by the Enforcement Committee and accepted by the Respondent whereby Respondent is assessed a fine of \$500, plus costs and attorney fees in the amount of \$411.80, which must be paid within 30 days of the effective date of the order. In addition, Respondent shall complete 2 hours of ethics CPE within 30 days to apply to the shortage. A proven violation of this ACO, the Act of the Board's Rules authorizes the Board to take such other and further action as the Board may deem appropriate under the Act. The Enforcement Committee recommends the Administrative Consent Order in this case be approved by the Board.

##### **OAB Records Summary**

CPE Status: Registrant is not in compliance. Registrant reported 47 hours for 2015 (includes 0 hours ethics); 53 hours for 2016 (includes 2 hours ethics); and 52 hours for 2017 (includes 0 hours ethics).

Peer Review Status: N/A.

Motion by Taylor that the Board approve Administrative Consent Order in Case no. 2227. Second by Manning.

Affirmative Votes: Taylor, Greenwell, Byford, Manning and Vernon.

**Agenda Item #9 – Discussion and possible action on the development of Oklahoma Accountancy Board guidance for CPAs regarding medical marijuana:** Executive Director Ross presented this item to the Board. A brief discussion took place.

Motion by Greenwell that the Board adopt the guidelines for compliance without contingency. Second by Manning.

Affirmative Votes: Taylor, Greenwell, Byford, Manning and Vernon.

**Agenda Item #7 – Discussion and possible action on report from Rules Promulgation and Legislative Committee:**

- Propose legislation to create an educational scholarship funded by fines collected through enforcement

Executive Director Ross informed the Board of the proposed bill that would create an educational scholarship fund for accounting students from fines collected by the Board through enforcement.

Motion by Greenwell that the Board approve the proposed legislation to create an educational scholarship funded by fines collected through enforcement. Second by Taylor.

Affirmative Votes: Taylor, Greenwell, Byford, Manning and Vernon.

- Adopt emergency rules to comply with HB 1373

Motion by Greenwell that the Board finds that there is an emergency situation and to adopt the emergency rules to comply with HB 1373. Second by Taylor.

Affirmative Votes: Taylor, Greenwell, Byford, Manning and Vernon.

- List of disqualifying crimes as provided in HB 1373

Member Greenwell presented this list to the Board. A lengthy discussion took place regarding the list of disqualifying crimes.

Motion by Greenwell to amend his previous motion to include “at least annually” to the emergency rule section 10:15-37-11(e) and to include language from the State of Delaware. Second by Manning.

Affirmative Votes: Taylor, Greenwell, Byford, Manning and Vernon.

After further discussion by the Board, Member Greenwell made an additional amendment to his motion.
