Determination of Quorum and Call to Order

Discussion from Kurt Kalies Regarding Ear Cleaning

Dr. Kalies presented information regarding ear cleaning and his concern that many audiologists are not properly trained nor have the necessary equipment to safely perform the service. The Board discussed various ways to address the problem. Suggestions included statutory or rule changes and consumer education efforts. No action was taken.
