#### **Determination of Quorum and Call to Order**

The meeting was called to order at 1:12pm. Ms. Hall called the roll. Board members present were Ms. Tracy Grammer, Dr. Greg A. Krempl, and Ms. Susan McHugh. A quorum was present.

Others present: Amy Hall, Executive Secretary and Sandra Balzer, Assistant Attorney General and guests; Lauren Mays.

#### **Approval of Minutes from December 12 Board Meeting**

Dr. Krempl moved and Ms. McHugh seconded the motion to approve the December 12 board meeting minutes as written. Ms. Grammer, Ms. McHugh, and Dr. Krempl voted yes with a show of hands. Motion approved.

#### **Discussion and Possible Action on Disciplinary Matters. The Board may conduct an evidentiary hearing, consider a proposed consent order, or consider other associated matters or motions. The Board may convene in executive session for deliberations pursuant to 25 O.S. Section 307(B)(8).**

##### **a. 12-01, Yvonne Cardenas, SP#3548 Review of Compliance with Consent Order**

Ms. Cardenas was not present. Ms. Balzer presented to the board that Ms. Cardenas has met all the terms of all three consent orders. Dr. Krempl moved and Ms. McHugh seconded the motion to accept Ms. Balzers recommendations that Ms. Cardenas has fully completed all the terms of all three consent orders, that her license was in good standing at the time it permanently expired on December 31, 2014 and to dismiss the complaint. Ms. Grammer, Ms. McHugh, and Dr. Krempl all voted yes with a show of hands. Motion approved. Yvonne Cardenas gave written permission for Ms. Grammer to vote on her dismissal despite that Ms. Grammer was the investigator.

#### **Discussion and Possible Action on Petition for Hardship Relief for Christa McAllister, SP#2524.**

The Board reviewed the petition from Ms. McAllister requesting for a hardship relief of her Continuing Education while in an inactive status. Dr. Krempl moved and Ms. McHugh seconded the motion to grant her request for hardship relief waiving requirements to earn Continuing Education hours while in an inactive status. When Ms. McAllister is ready to reactivate her license she will need to follow in accordance of guidelines in rule 690:L10-9-7. Ms. Grammer, Ms. McHugh, and Dr. Krempl all voted yes with a show of hands. Motion approved.

### **Nancy Bryant, SP#458, Amber Diaz, SP#3274 and Deborah Young, SP#570**

Ms. Hall addressed the Board concerning Nancy Bryant, Amber Diaz, and Deborah Young not being tax compliant, but all did make timely renewal of their license for 2015. Ms. McHugh moved and Dr. Krempf seconded the motion to table the renewal of Nancy Bryant, Amber Diaz, and Deborah Young until next Board meeting. Ms. Grammer, Dr. Krempf, and Ms. McHugh all voted yes with a show of hands. Motion approved.
