Determination of Quorum and Call to Order

The meeting was called to order at 1:01pm. Amy Hall called the roll. Board members present were Dr. Mary Hudson, Ms. Tracy Grammer, Dr. Greg A. Krempl and Ms. Kristin Hopper. A quorum was present.

Approval of Minutes from April 16, 2014 Board Meeting

Dr. Krempl moved and Ms. Hopper seconded the motion to approve the April 16 board meetings minutes as written. Ms. Grammer, Dr. Hudson, Ms. Hopper, and Dr. Krempl voted yes with a show of hands. Motion approved.
