

# Featured Speakers

## **Steven Malcolm Berg-Smith, MS**

For over 22 years, Steven Malcolm Berg-Smith has worked as a health educator, behavior change counselor, drug and alcohol prevention specialist, and researcher. He currently has a private practice in San Francisco as a trainer, consultant, mentor, and health counselor.

A member of the International Motivational Interviewing Network of Trainers since 1994, Steven has conducted over 300 workshops throughout the U.S. and internationally on strategies for motivating behavior change in brief clinical encounters, designed behavior change intervention protocols for several national clinical research trials, and, in 2006, was selected to co-facilitate the Motivational Interviewing "Training for Trainers" program in Miami, FL. He has authored several frequently cited articles on how to use motivation-enhancing tools and strategies to support adolescents and adults in making positive lifestyle changes.

## **Father Greg Boyle, SJ**

Fr. Gregory Boyle was born in Los Angeles, one of eight children. His father, a third-generation Irish-American, worked in the family-owned dairy in Los Angeles County and his mother worked to keep track of her large family. As a youth, Fr. Greg and several of his siblings worked side by side with their father in the dairy. After graduating from Loyola High School in 1972, he decided to become a Jesuit and was ordained a priest in 1984. He received his BA in English from Gonzaga University; an MA in English from Loyola Marymount University; a Master of Divinity from the Weston School of Theology; and a Sacred Theology Masters degree from the Jesuit School of Theology.

Homeboy Industries is a program created in 1988 by Fr. Greg at Dolores Mission parish. In an effort to address the escalating problems and unmet needs of gang-involved youth, Fr. Greg and the community developed positive alternatives, including establishing an elementary school, a day care program, and finding legitimate employment for young people. In 1992, Fr. Greg launched the first business - Homeboy Bakery - with a mission to create an environment that provided training, work experience, and above all, the opportunity for rival gang members to work side by side. Today Homeboy Industries' nonprofit economic development enterprises include: *Homeboy Bakery, Homeboy Silkscreen, Homeboy Maintenance, Homeboy/Homegirl Merchandise, and Homegirl Café.*

As Executive Director of Homeboy Industries and an acknowledged expert on gangs and intervention approaches, Fr. Greg is a nationally renowned speaker. He has given commencement addresses at several prestigious universities as well as spoken at conferences for teachers, social workers, criminal justice workers, and others about the importance of adult attention, guidance, and unconditional love in preventing youth from joining gangs. Fr. Greg and several "homies" were featured speakers at the White House Conference on Youth in 2005 at the personal invitation of Mrs. George Bush. Fr. Greg is also a consultant to youth service and governmental agencies, policy-makers, and employers.

Homeboy Industries, located in downtown Los Angeles, is recognized as the largest gang intervention program in the county, and has become a national model.



## **Karl Dennis, BS**

Karl Dennis is a youth worker, a teacher, and a cultivator of strengths. His profound reputation is based on a fundamental principle which he brought to life and seeded - that children can best be served in their families, in their communities; that the assets and strengths of their situation are best known to those closest to the child; that wrapping the youngster and family with individual human care, supervision, and concern is safer, better, and cheaper than tearing apart child, family, community, and systems.

Karl retired as the Executive Director of Kaleidoscope, Inc., a non-profit community-based childcare agency in Chicago, where he provided leadership and vision for 27 years. He is one of the country's leading experts and pioneers of community-based care for the "hardest to serve children and families," including Wraparound services, therapeutic foster care, pediatric AIDS care, independent living, and long-term intensive family preservation services. Under Karl's direction, Kaleidoscope became nationally recognized as one of the top five child serving agencies in the country. He has helped orchestrate many state and private initiatives to return children from out-of-state placements and has provided direct services to thousands of children and their families.

Karl has trained in all 50 states and many foreign countries. He has been the keynote speaker for such prestigious conferences such as the: National Conference of Juvenile Court Judges, Rosalyn Carter's Mental Health Conference, and Tipper Gore's National Mental Health Symposium. He aided in the development of Wraparound services in New Zealand.

Karl's first book, "Everything is Normal Until Proven Otherwise," was written in collaboration with Dr. Ira Lourie, noted child psychiatrist and former head of CASSP. The book is a series of stories about the children and families that Karl has worked with over the years coupled with commentary by Dr. Lourie. Written for parents and professionals, the book provides Wraparound guidance on the effectiveness of the process when people use creativity and compassion in the delivery of services. Part African American, Cherokee, Blackfoot, and Irish, Karl brings to his presentations an understanding of culture and the important role that it plays in the healing process. Karl has received many honors for his visionary work but he is truly revered for his passion, humor, and humanity in working with those who are most often forgotten.

## **Kathy Dennis, BS**

Kathy has recently retired as Director of Development and Training for Kaleidoscope where she worked for the past 12 years. Along with her husband, Karl, they have provided training and technical assistance in all 50 states and many foreign countries. Ms. Dennis is a nationally recognized trainer of intensive, individualized mental health intervention services for youth and families, family advocacy, and funding of child caring services. She is known for her many fundraising and grant writing workshops and seminars.

In addition to her work at Kaleidoscope, Kathy was the lead technical assistant to the Annie E. Casey urban mental health initiative in Houston, Texas. She is a past national board of directors' member of the Federation of Families, a national family advocacy organization in Washington DC. Ms. Dennis' fundraising experience comes from her positions as the director of development for the Omaha Symphony Orchestra, Kaleidoscope, and as a regional executive director for Planned Parenthood of Wisconsin. Currently, she serves on the Board of Directors of the Shirley Heinze Land Trust, chairs the Settlement Committee for Tryon Farm, an environmental housing project in NW Indiana, and is a member of the Lubeznik Center for the Arts development committee. She and Karl have provided intensive training in New Zealand and Guam and have provided consultation to groups from Russia, Poland, England, and China. She has thirty-five years experience working in both the public and private sectors and has been recognized in Wisconsin and Nebraska for her outstanding professional and community services.

## **Bruce Kamradt, MSW**

Bruce Kamradt is the Administrator of Children's Mental Health Services for Milwaukee County and Director of Wraparound Milwaukee, which is a unique system of care that annually serves over 1,300 children with serious emotional and mental health needs and their families. Created as one of the first publically operated managed care entities in the country, Wraparound Milwaukee combines over \$45 million per year from Medicaid, Mental Health, Child Welfare, Juvenile Justice, and the schools to provide a comprehensive array of services and supports for families.

Wraparound Milwaukee operates from an individualized, strength-based, and family-driven care philosophy utilizing components including care coordination, mobile crisis teams, and an extensive array of over 70 services and supports delivered by a provider network of over 200 agencies.

Wraparound Milwaukee was recognized in 2004 by the President's New Freedom Commission on Mental Health as an exemplary program in children's mental health and was Harvard University's Kennedy School of Government's 2009 winner of the Best Innovation in American Government. Mr. Kamradt has served as a consultant to many states and communities on Systems of Care design, development, and financing and has written numerous articles, papers, and monographs on the Wraparound Milwaukee model.

## **Ken Martinez, Psy.D.**

Dr. Martinez, a native New Mexican, has been a licensed clinical psychologist for over 30 years and has worked in the behavioral health field in a variety of capacities including clinician, university faculty, state administrator, consultant, technical assistance provider, and volunteer. He is currently Principal Research Analyst and Mental Health Resource Specialist with the Technical Assistance Partnership for Child and Family Mental Health (Technical Assistance Partnership) at the American Institutes for Research in Washington, DC, based in Corrales, New Mexico. Dr. Martinez is lead for the TA Partnership's Cultural Competence Action Team which published the web-based document "The Cultural and Linguistic Competence Implementation Guide" and several other cultural and linguistic competence related products. Dr. Martinez was the State Children's Behavioral Health Director in New Mexico. He is the Clinical Assistant Professor of Psychiatry at the University of New Mexico Health Sciences Center and guest lecturer in the Department of Child and Family Studies at the University of South Florida. He has served on the Rosalynn Carter Mental Health Symposium Planning Committee at the Carter Center and is currently on numerous national boards including the National Alliance of Multi-Ethnic Behavioral Health Associations, the National Latino Behavioral Health Association, the National Network to Eliminate Disparities in Behavioral Health, the National Advisory Committee for the Research and Training Center for Pathways to Positive Futures at Portland State University, and is a member of the SAMHSA-sponsored Outcomes Roundtable for Children and Families.

## **Steven Mullen, BS, CTRS**

Steven Mullen is a trainer/consultant with The University of Oklahoma OUTREACH National Resource Center for Youth Services. He has served as the director of expressive therapies for a psychiatric hospital treating children and adolescents. As a certified therapeutic recreational specialist and R.O.P.E.S. course facilitator, Steven has extensive experience working with youth at all levels of care in various types of treatment and social settings. Steven's areas of expertise include behavioral support, milieu management, experiential therapy, and positive youth development.

## **Cardwell C. Nuckols, MA, Ph.D.**

Dr. Cardwell C. Nuckols is described as “one of the most influential clinical trainers in North America.” Dr. Nuckols’ passion and mission is to assist in the integration of emerging scientific research with traditional spiritual and self-help knowledge. From this integration comes knowledge and techniques helpful to those whose practice assists substance abuse and mental health patients find healing and their personal road to recovery. An internationally recognized expert in such areas as behavioral medicine and addictions treatment, Dr. Nuckols has been a clinical and developmental consultant for over thirty years.

## **Joy Osofsky, Ph.D.**

Joy D. Osofsky, Ph.D. is a psychologist, psychoanalyst, and Professor of Pediatrics and Psychiatry at Louisiana State University Health Sciences Center in New Orleans. She is Head of the Division of Pediatric Mental Health. She is an Adjunct Professor of Psychology at the University of New Orleans. Dr. Osofsky is Co-Director of the Louisiana Rural Trauma Services Center, a center in the National Child Traumatic Stress Network and Director of the Harris Center for Infant Mental Health at LSUHSC. After Hurricane Katrina, she was asked to be Director for Child and Adolescent Initiatives for Louisiana Spirit, the State Crisis Counseling Program. She is editor of *Children in a Violent Society* (Guilford, 1997; paper, 1998), two editions of the *Handbook of Infant Development* (Wiley, 1979; 1987), and co-editor of the four volume *WAIMH Handbook of Infant Mental Health* that received the American Publishers Association award as the best social science reference book in 2000. Dr. Osofsky’s 2004 (paperback 2007) edited book, *Young Children and Trauma: Intervention and Treatment*, includes contributions related to mental health, child welfare, the judiciary, and law enforcement. Dr. Osofsky is also editor of the *Infant Mental Health Journal*.

## **Michael Rauso, Psy.D, MFT**

Michael J. Rauso, Psy.D., MFT is the Wraparound Director for the Los Angeles County Department of Children and Family Services (DCFS). Los Angeles County’s Wraparound currently serves over 1,200 children from DCFS, Probation and Mental Health. Dr. Rauso is director of the Family to Family Initiative, System of Care, Family Group Decision Making, Parents in Partnership, and other strength-based, community-focused programs for DCFS. Prior to his current position at DCFS, he worked for a community-based organization which was one of the first Wraparound agencies in the county.

## **Cortney Yarholar, MSW**

Cortney Yarholar, MSW is an enrolled member of the Sac & Fox Nation of Oklahoma as well as descendent of the Creek, Pawnee and Otoe Tribes. He is a mental health professional specializing in Children, Youth and Family services and multiple community health development projects. He has a particular interest in decreasing suicide among youth and eliminating behavioral health disparities among tribal communities. He recognizes the unique resiliency within each tribal community that has empowered American Indian people to endure generations of historical trauma. He further helps individuals to recognize and bring to surface their personal resiliency to initiate a strengths-based position to empower youth and family together.

In 2003, he attained his BA from the University of Oklahoma, majoring in Native American Studies. In 2006, he attained his Master’s in Social Work from Washington University in St. Louis, MO. He currently works with the Oklahoma Department of Mental Health & Substance Abuse Services as the Tribal State Liaison for community-based services and state transformation efforts. He is a certified instructor of Mental Health First Aid and Question Persuade & Refer (QPR) Suicide Prevention trainings. In 2008, he became certified by the National Multi Cultural Institute as an instructor of cultural competency. Since then he strives to help organizations be more culturally responsive, responsible, and competent for the people they serve.

# Session Descriptions

Pre-Conference Institute: Wednesday, April 28

## Title

### **Child and Adolescent Disruptive Behaviors, *Cardwell C. Nuckols, MA, Ph.D.***

Child and adolescent development involves testing boundaries, delaying gratification, completing tasks, dealing with emotions, and learning interpersonal skills. For some, these tasks are much harder to perform and problems develop. In severe instances, the behavior creates severe interpersonal, school, family, and community problems. This skills training will focus on the interplay between addictive disorders and other disruptive disorders such as ADHD, Conduct Disorder, Adjustment Disorder with Conduct Features, and others.

### ④ ..... **Trauma through the Eyes of a Young Child and Applying the Science of Early Childhood Development to Understanding Maltreated Young Children, *Joy Osofsky, Ph.D.***

This workshop will provide information and raise awareness about the effects of trauma on young children and caregivers, how to recognize “red flags”, and the importance of a relationship perspective for understanding, helping, and treating young children. The presentation will show how the science of early childhood development is important to an understanding of the effects of trauma. Information will also be included on the risk for vicarious traumatization and compassion fatigue in working with high risk young children and the need for support for those who do this important work.

### **Wraparound – Thirty Years Experience & Why It Is Worth It**

*Karl Dennis, BS, Kathy Dennis, BS and Bruce Kamradt, MSW*

# Workshop Descriptions – Session 1

Thursday, April 29



Session Title

- 1A.....④ ..... **Life Development Trauma (Part 1)**, *Cardwell C. Nuckols, MA, Ph.D.*  
This skills training event will focus on the treatment of early life developmental trauma. Emphasis will be placed on the understanding of current research from such disciplines as neuroscience, neuropsychology, and attachment theory. Participants can expect to hear what the research tells us about this population and how this evidence can be used to help. Practical treatment techniques translated from the research will give participants hands-on skills that can be used for better client understanding and clinical outcomes.
- 1B.....④ ..... **Resiliency Despite Risk**, *Belinda Biscoe, Ph.D.*  
Moving the construct of resilience from esoteric to the concrete critical as professionals seek ways to promote internal strengths in children, youth, and families most at-risk. Professionals will become better equipped as they learn about strategies and interventions that promote and nurture competence, efficacy, and other positive aspects of a young person's development.
- 1C.....  ..... **Going from Good to Great**, *Bruce Kamradt, MSW*  
Wraparound Milwaukee was recognized in 2004 by the President's New Freedom Commission on Mental Health as an exemplary program in children's mental health and was Harvard University's Kennedy School of Government's 2009 winner of the Best Innovation in American Government. Mr. Kamradt will share how to successfully integrate services and funding across child serving systems to achieve the best possible outcomes for children, youth, and families.
- 1D.....④ ..... **Attachment Issues in Children and Youth**, *Rhonda Noonan, MS, LPC*  
This workshop will focus on the etiology of attachment disorders and three maladaptive behaviors developed in response to the early trauma. Discussion of an effective parenting approach that addresses the specific needs of these children will follow. The goal of this presentation is an overall, basic understanding of attachment disorder and how to maintain safe, reparative relationships.
- 1E ..... **Early Childhood Mental Health Consultation: Benefits of Providing Services to Child Care**, *Amy Huffer, LCSW*  
Research indicates that more very young children are being expelled from child care at high rates and that mental health consultation can be beneficial in supporting child care professionals and effective in reducing expulsion rates. Though the service is specifically designed to address child care providers, mental health professionals and others will benefit from learning more about this valuable resource and how to bring this service to your community.

1F ..... **Elements of Wraparound and Reclaiming Lives**

*Karl Dennis, BS and Kathy Dennis, BS*

The Wraparound process involves surrounding children and families with people and services instead of walls and providing family-driven, strength-based services which are culturally competent and unconditional. Wraparound outcomes will be discussed.


