

Ethical Dilemmas in Crisis Settings

This presentation will provide an overview of professional boundary and other ethical issues encountered when delivering mental health services in a crisis setting. The focus is on ethical issues encountered in a variety of inpatient and outpatient settings. This class will present the application of general psychiatric assessment skills to facilitate an Emergency Detention as warranted by Oklahoma Title 43A. We will discuss how to use the basics of a mental status exam to address standards of immediate danger and discuss some modified real-life examples to determine how the caveats of a given situation may effect qualification for Emergency Detention.
