



## Featured Speaker

Ray Caesar, LPC, LADC currently works for the Oklahoma Department of Mental Health and Substance Abuse Services. He is responsible for the certification of all ADSAC (DUI) organizations, facilitators, assessors and assessment agencies. He is also in charge of the loan fund and development program for Oxford House and is the State Opioid Treatment Authority. Mr. Caesar has worked in the addictions field for over thirty years, as a clinician, educator, consultant, author, and program director. Mr. Caesar received both his undergraduate in psychology and his graduate degree in counseling psychology from the University of Central Oklahoma in Edmond, is licensed as a professional counselor (LPC) and as an alcohol and drug counselor (LADC).
