**Discussion: Proposed Permanent Rule Changes:** Mrs. Launey-Rodolf spoke about the process and timeline for changing rules in state government. She then presented proposed permanent rule changes that would align OEQA rules to current state standards and simplify wording of rules related to state accreditation of Educator Preparation Programs. Mr. Parker made suggestions for rule changes on accreditation standards that would benefit teachers going through Educator Preparation Programs.

**Presentation and Discussion: P12 Transfer Audits:** David Kurt presented information on current progress for P12 Transfer Audits in relation to SB 783 and HB 3038. He spoke about the initial issues schools encountered and then gave information about the ongoing review of 10% of school districts in the state, as per statute.

**Program Updates:** Angie Bookout spoke about school performance reviews, telling the Commission about the current progress being made. Jennifer Gambrell spoke about recruiting National Board Certified Teachers. She then spoke about PPAT Support Providers and the progress being made on a pilot mentoring program authorized by SB 1631.

**Announcements and Informational Items:** Mrs. Launey-Rodolf told the commission that they would have accreditation decisions ready for vote at the upcoming December 14, 2022 regular meeting.
