

Teen Drivers Age 16-19 in Crashes (2014)

Alcohol-Related Driver Condition

Demographics

As shown in the chart below, in 2014 teens represented 5.3% of Oklahoma's total population, 5.6% of the total licensed drivers and 10.1% of all drivers involved in crashes. The percentage of teen drivers with an alcohol-related driver condition decreased 1.6% from 224 in 2013 to 177 in 2014.



The percentage of teen drivers with an alcohol-related driver condition involved in crashes decreased less than one percent from 2011 to 2012.

Driver Age & Sex

In 2014, a total of 177 drivers age 16-19 involved in crashes had an alcohol-related driver condition. The table to the right shows that as driver age increased involvement in crashes also increased.

Of the drinking drivers age 16-19 involved in crashes, 39.0% were age 19, 35.6% were age 18, 18.1% were age 17 and 7.3% were age 16.


Of the drivers age 16-19 with an alcohol-related driver condition, 76.8% were male.

Time & Day


More than half of the crashes (58.2%) involving a drinking driver age 16-19 occurred between 8:00 p.m. (20:00) and 3:59 a.m. (03:59).

More crashes involving drinking drivers age 16-19 occurred on Saturday and Sunday than any other day of the week.



Seat Belt Use by Driver Fatalities


Seven driver fatalities age 16-19 who were drinking were occupants of a passenger vehicle or pickup truck. Of these seven drivers, five (71.4%) were unrestrained.




Rural vs. Urban
