**CONSENT ORDER**

COMES NOW the State of Oklahoma, ex rel. Kim Holland, Insurance Commissioner, and the Respondent James Manuel, Jr. and enter into this Consent Order.

**JURISDICTION**

1. That the Insurance Commissioner has jurisdiction of this cause, pursuant to the provisions of the Oklahoma Bail Bond Code, OKLA. STAT. tit. 59, §§ 1301-1340.
2. That Respondent James Manuel, Jr. is a licensed bail bondsman in the State of Oklahoma holding license number 800777.
3. That Respondent James Manuel, Jr. has been apprised of his rights including the right to a public hearing and has knowingly and freely waived said rights and enters into this Consent Order as a voluntary settlement to the issues and questions raised in the above captioned case.

**STIPULATIONS OF FACT**

1. On or about August 3, 2006, appearance bonds were issued as follows:

CITY/COUNTY:	Payne County
BAIL BONDSMAN:	James Manuel, Jr.
INSURER:	Sam Goad

BOND AMOUNT:	\$2,500.00, \$500.00, \$1,000.00

2. On or about September 8, 2006, the bond forfeitures were forfeited and Orders and Judgments of Forfeiture were issued.

3. The Defendant was not returned to custody within ninety (90) days nor were the forfeitures paid within ninety-one (91) days.

4. The forfeitures were untimely paid on April 25, 2007.

#### CONCLUSIONS OF LAW


1. Respondent James Manuel, Jr. has violated OKLA. STAT. tit. 59, § 1332(D) by failing to deposit cash or other valuable securities in the face amount of the bond with the Court Clerk ninety-one (91) days from receipt or mailing of the Order and Judgment of Forfeiture from the Court Clerk.


#### ORDER AND CONSENT






