



### **STIPULATION OF FACTS**

1. The Oklahoma Insurance Department (“Department”) received notice on July 5, 2007 from Respondent David R. Davis that he had adjusted 352 claims since January 2003 while unlicensed. (Exhibit “A”)

2. A Notice of Hearing was filed on August 22, 2007 alleging a violation of the Insurance Adjuster Licensing Act, 36 O.S. § 6220(A)(9) and 6204. (Exhibit “B”).

3. Respondent waived his right to the hearing and agreed to enter into a Consent Order and pay a \$1,000.00 fine for his violation of the Insurance Adjuster Licensing Act. It was agreed that upon payment of the fine, his adjuster license would be reinstated.

4. Respondent contends that he never received the Consent Order and that is the reason Respondent never returned the original Consent Order or paid the \$1,000.00 fine.

5. Respondent has continued to hold himself out as an adjuster under his business name “Frontier Adjusters” while unlicensed. (Exhibit “C”).


### **AGREED CONCLUSIONS OF LAW**

Respondent has violated 36 O.S. § 6220 (A)(8) and 6204 by acting or holding himself out as an adjuster in this state while unlicensed.

**ORDER**

**IT IS THEREFORE ORDERED** by the Insurance Commissioner and agreed by Respondent that a **ONE THOUSAND DOLLAR (\$1,000.00) fine** is imposed against Respondent, payable in four monthly installments of \$250.00 each. The four \$250.00 installment payments shall be paid by money order or cashiers check made payable to the Oklahoma Insurance Department. Respondent's adjuster license shall not be reinstated until the \$1,000.00 fine is paid in full.


