**CONSENT ORDER**

COMES NOW the State of Oklahoma, ex rel. Kim Holland, Insurance Commissioner, and the Respondent and enter into this Consent Order.

**JURISDICTION**

1. That the Insurance Commissioner has jurisdiction of this cause, pursuant to the provisions of the Oklahoma Bail Bond Code, OKLA. STAT. tit. 59, §§ 1301-1340.
2. That Respondent is a licensed bail bondsman in the State of Oklahoma holding license number 800570/200069.
3. That Respondent has been apprised of her rights including the right to a public hearing and has knowingly and freely waived said rights and enters into this Consent Order as a voluntary settlement to the issues and questions raised in the above captioned case.

**STIPULATIONS OF FACT**

1. Respondent failed to timely file her June 2007 monthly cash report by July 16, 2007.
2. Said report was postmarked July 19, 2007 and received by Petitioner on July 20, 2007.
3. Respondent failed to timely file her July 2007 monthly cash report by August 15, 2007.
4. Said report was postmarked on August 16, 2007 and received by Petitioner on August 17, 2007.


**CONCLUSIONS OF LAW**

1. Respondent has violated OKLA. STAT. tit. 59, § 1310(A)(22), 1314(B)(1), and OKLA. ADMIN. CODE 365:25-5-36 by failing to timely file her June and July 2007 monthly cash reports.

**ORDER AND CONSENT**

IT IS THEREFORE ORDERED by the Insurance Commissioner and CONSENTED to by the Respondent that she shall be and hereby is fined in the amount of **One Hundred and No/100 Dollars (\$100.00)**. Fine to be paid immediately.


