3. That Respondent has been apprised of his rights including the right to a public hearing and has knowingly and freely waived said rights and enters into this Consent Order as a voluntary settlement to the issues and questions raised in the above captioned case.

**STIPULATIONS OF FACT**

1. Respondent failed to timely file his July 2007 monthly cash report and his July 2007 Safety National Casualty Corporation monthly surety report by August 15, 2007.
2. Said reports were postmarked August 16, 2007 and received by Petitioner on August 17, 2007.


**CONCLUSIONS OF LAW**

1. Respondent has violated OKLA. STAT. tit. 59, § 1310(A)(22), 1314(B)(1), and OKLA. ADMIN. CODE 365:25-5-36 by failing to timely file his July 2007 monthly cash report and his July 2007 monthly Safety National Casualty Corporation monthly surety report.


**ORDER AND CONSENT**




