3. That Respondent has been apprised of her rights including the right to a public hearing and has knowingly and freely waived said rights and enters into this Consent Order as a voluntary settlement to the issues and questions raised in the above captioned case.

STIPULATIONS OF FACT

1. Respondent failed to timely file her June 2007 cash monthly report and her June 2007 International Fidelity Insurance Company monthly surety report by July 16, 2007.
2. Said report was postmarked on July 17, 2007 and received by Petitioner on July 20, 2007.

CONCLUSIONS OF LAW


1. Respondent has violated OKLA. STAT. tit. 59, § 1310(A)(22), 1314(B), and OKLA. ADMIN. CODE 365:25-5-36 by failing to timely file her June 2007 cash monthly report and her June 2007 International Fidelity Insurance Company monthly surety

report.

ORDER AND CONSENT

IT IS THEREFORE ORDERED by the Insurance Commissioner and CONSENTED to by the Respondent that he shall be and hereby is fined in the amount of **One Hundred Fifty and No/100 Dollars (\$150.00)**. Fine is to be paid immediately.
