CONSENT ORDER

JURISDICTION

1. That the Insurance Commissioner has jurisdiction of this cause, pursuant to the provisions of the Oklahoma Bail Bond Code, OKLA. STAT. tit. 59, §§ 1301-1340.
2. That Respondent is a licensed bail bondsman in the State of Oklahoma holding license number 803164/77116.
3. That Respondent has been apprised of his rights including the right to a public hearing and has knowingly and freely waived said rights and enters into this Consent Order as a voluntary settlement to the issues and questions raised in the above captioned case.

STIPULATIONS OF FACT

1. Respondent failed to timely file his July 2007 Fairmont Specialty Insurance Company, f/k/a Ranger Insurance Company, monthly surety report by August 15, 2007.
2. Said report was delivered to Petitioner via the drop box on August 20, 2007.
3. Respondent failed to timely file his August 2007 Fairmont Specialty Insurance Company, formerly known as Ranger Insurance Company, monthly surety report by September 17, 2007.

4. As of the date of this Notice, Respondent's August 2007 Fairmont Specialty Insurance Company, formerly known as Ranger Insurance Company, monthly surety report has not been filed.

5. Respondent failed to timely file his September 2007 Fairmont Specialty Insurance Company, formerly known as Ranger Insurance Company, monthly surety report by October 15, 2007.

6. As of the date of this Notice, Respondent's September 2007 Fairmont Specialty Insurance Company, formerly known as Ranger Insurance Company, monthly surety report has not been filed.

7. Respondent failed to timely file his October 2007 Fairmont Specialty Insurance Company, f/k/a Ranger Insurance Company, monthly surety report by November 15, 2007.

8. As of the date of this Notice, Respondent's October 2007 Fairmont Specialty Insurance Company, formerly known as Ranger Insurance Company, monthly surety report has not been filed.

9. Respondent failed to timely file his November 2007 Fairmont Specialty Insurance Company, f/k/a Ranger Insurance Company, monthly surety report by November 15, 2007.

10. As of the date of this Notice, Respondent's November 2007 Fairmont Specialty Insurance Company, formerly known as Ranger Insurance Company, monthly surety report has not been filed.

CONCLUSIONS OF LAW


1. Respondent has violated OKLA. STAT. tit. 59, § 1310(A)(22), 1314(B)(1), and OKLA. ADMIN. CODE 365:25-5-36 by failing to timely file his July 2007, August 2007, September 2007, October 2007, and November 2007 Fairmont Specialty Insurance Company, f/k/a Ranger Insurance Company, monthly surety reports.

ORDER AND CONSENT


IT IS THEREFORE ORDERED by the Insurance Commissioner and CONSENTED to by the Respondent that he shall be and hereby is fined in the amount of **Five Hundred and No/100 Dollars (\$500.00)**. Fine to be paid immediately.

IT IS FURTHER ORDERED by the Insurance Commissioner and CONSENTED to by the Respondent that his August 2007, September 2007, October 2007, and November 2007 Fairmont Specialty Insurance Company, f/k/a Ranger Insurance Company, monthly surety reports are to filed immediately. If they are not filed by February 15, 2008, Respondent's license will be suspended and will remain suspended until the reports are filed.


