**CONSENT ORDER**

2. That Respondent is a licensed bail bondsman in the State of Oklahoma holding license number 800490/199772.
3. That Respondent has been apprised of her rights including the right to a public hearing and has knowingly and freely waived said rights and enters into this Consent Order as a voluntary settlement to the issues and questions raised in the above captioned case.

**STIPULATIONS OF FACT**

1. Respondent failed to timely file her June 2007 cash monthly report by July 16, 2007.
2. Said report was postmarked July 21, 2007 and Petitioner received it on July 23, 2007.
3. Respondent failed to timely file her August 2007 cash monthly report by September 17, 2007.

4. Said report was postmarked September 26, and Petitioner received it on September 26, 2007.

**CONCLUSIONS OF LAW**


1. Respondent has violated OKLA. STAT. tit. 59, § 1310(A)(22), 1314(B), and OKLA. ADMIN. CODE 365:25-5-36 by failing to timely file her June and August, 2007 cash monthly reports.


**ORDER AND CONSENT**

IT IS THEREFORE ORDERED by the Insurance Commissioner and CONSENTED to by the Respondent that she shall be and hereby is **censured**.






