CONSENT ORDER

COMES NOW the State of Oklahoma, ex rel. Kim Holland, Insurance Commissioner, and the Respondent and enter into this Consent Order.

JURISDICTION

1. That the Insurance Commissioner has jurisdiction of this cause, pursuant to the provisions of the Oklahoma Bail Bond Code, OKLA. STAT. tit. 59, §§ 1301-1340.
2. That Respondent is a licensed bail bondsman in the State of Oklahoma holding license number 800870/200106.
3. That Respondent has been apprised of his rights including the right to a public hearing and has knowingly and freely waived said rights and enters into this Consent Order as a voluntary settlement to the issues and questions raised in the above captioned case.

STIPULATIONS OF FACT

1. Respondent failed to timely file his July 2007 monthly cash report and his July 2007 American Contractors Indemnity Company monthly surety report by August 15, 2007.
2. Said reports were hand delivered to Petitioner on September 18, 2007.
3. Respondent failed to timely file his August 2007 monthly cash report and his August 2007 American Contractors Indemnity Company monthly surety report by September 17, 2007.
4. Said reports were hand delivered to Petitioner on September 18, 2007.

CONCLUSIONS OF LAW

1. Respondent has violated OKLA. STAT. tit. 59, § 1310(A)(22), 1314(B), and OKLA. ADMIN. CODE 365:25-5-36 by failing to timely file his July 2007 and August 2007 monthly cash reports and his July 2007 and August 2007 American Contractors Indemnity Company monthly surety reports.


ORDER AND CONSENT

IT IS THEREFORE ORDERED by the Insurance Commissioner and CONSENTED to by the Respondent that he shall be and hereby is **censured**.






