**CONSENT ORDER**

COMES NOW the State of Oklahoma, ex rel. Kim Holland, Insurance Commissioner, and the Respondent and enter into this Consent Order.

**JURISDICTION**

1. That the Insurance Commissioner has jurisdiction of this cause, pursuant to the provisions of the Oklahoma Bail Bond Code, OKLA. STAT. tit. 59, §§ 1301-1340.
2. That Respondent is a licensed bail bondsman in the State of Oklahoma holding license number 800834/199938.
3. That Respondent has been apprised of his rights including the right to a public hearing and has knowingly and freely waived said rights and enters into this Consent Order as a voluntary settlement to the issues and questions raised in the above captioned case.

**STIPULATIONS OF FACT**

1. Respondent failed to timely file his June 2007 Safety National Casualty Corporation monthly surety report by July 16, 2007.
2. Petitioner received said report on September 18, 2007.
3. Respondent failed to timely file his September 2007 Safety National Casualty Corporation monthly surety report by October 15, 2007.
4. Petitioner received said report on December 13, 2007.

**CONCLUSIONS OF LAW**

1. Respondent has violated OKLA. STAT. tit. 59, § 1310(A)(22), 1314(B)(1), and OKLA. ADMIN. CODE 365:25-5-36 by failing to timely file his July 2007 and September 2007 Safety National Casualty Corporation monthly surety report.


**ORDER AND CONSENT**


