3. That Respondent has been apprised of her rights including the right to a public hearing and has knowingly and freely waived said rights and enters into this Consent Order as a voluntary settlement to the issues and questions raised in the above captioned case.

STIPULATIONS OF FACT

1. Respondent failed to file her June 2007 monthly cash report by June 15, 2007.
2. Respondent failed to file her July 2007 monthly cash report by August 15, 2007.
3. Respondent failed to file her August 2007 monthly cash report by September 17, 2007.

4. Respondent failed to file her September 2007 monthly cash report by October 15, 2007.

5. Respondent failed to file her October 2007 monthly cash report by November 15, 2007.

6. Said reports were untimely filed on December 30, 2007.

CONCLUSIONS OF LAW


1. Respondent has violated OKLA. STAT. tit. 59, § 1310(A)(22), 1314(B)(1), and OKLA. ADMIN. CODE 365:25-5-36 by failing to timely file her June, July, August, September and October 2007 cash monthly reports.

ORDER AND CONSENT

IT IS THEREFORE ORDERED by the Insurance Commissioner and CONSENTED to by the Respondent that she shall be and hereby is fined in the amount of **One Hundred and No/100 Dollars (\$100.00)**. Fine to be paid immediately.




