CONSENT ORDER

COMES NOW the State of Oklahoma, ex rel. Kim Holland, Insurance Commissioner, and the Respondent Russell Riley (hereinafter Respondent), and enter into this Consent Order.

JURISDICTION

1. That the Insurance Commissioner has jurisdiction of this cause, pursuant to the provisions of the Oklahoma Bail Bond Code, OKLA. STAT. tit. 59, §§ 1301-1340.
2. That Respondent was a licensed bail bondsman in the State of Oklahoma holding license number 800974/199731. However, he failed to renew his license by September 30, 2007. As a result, it expired on October 1, 2007.
3. That Respondent has been apprised of his rights including the right to a public hearing and has knowingly and freely waived said rights and enters into this Consent Order as a voluntary settlement to the issues and questions raised in the above captioned case.

STIPULATIONS OF FACT

1. Respondent failed to file his September 2007 Safety National Casualty Company monthly surety report by October 15, 2007. The report was untimely filed on November 15, 2007.

CONCLUSIONS OF LAW


1. Respondent has violated OKLA. STAT. tit. 59, § 1310(A)(22), 1314(B), and OKLA.

ADMIN. CODE 365:25-5-36 by failing to timely file his September 2007 Safety National Casualty Company.

ORDER AND CONSENT

IT IS THEREFORE ORDERED by the Insurance Commissioner and CONSENTED to by the Respondent that he shall be and hereby is fined in the amount of **One Hundred and No/100 Dollars (\$100.00)**. Issuance of a new license is condition in part on paying the above referenced fine.
