**CONSENT AGREEMENT**

COMES NOW the State of Oklahoma, ex rel. Kim Holland, Insurance Commissioner, and the Respondent and enter into this Consent Order.

**JURISDICTION**

1. That the Insurance Commissioner has jurisdiction of this cause, pursuant to the provisions of the Oklahoma Bail Bond Code, OKLA. STAT. tit. 59, §§ 1301-1340.
2. That Respondent is a licensed bail bondsman in the State of Oklahoma holding license number 800691/200294.
3. That Respondent has been apprised of her rights including the right to a public hearing and has knowingly and freely waived said rights and enters into this Consent Order as a voluntary settlement to the issues and questions raised in the above captioned case.

**STIPULATIONS OF FACT**

1. Respondent failed to timely report bonds written on Lamont Armond Harris and Christopher Stephon Anderson on Respondent's January 2007 professional report.

After notification by the Petitioner, the bonds were reported on Respondent's February 2007 report an.

2. Respondent failed to timely report bonds written on Laramie Massey on her February 2007 report and failed to submit \$2.34 in additional reviewal fees. The bond was subsequently reported on her March 2007 professional report and the reviewal fees paid on April 30, 2007

3. Respondent failed to timely report bonds written on Robert Cornett, Christopher Norfleet, Kyle Ellenburg, Willie Johnson, Roy Britton, and Christopher Norfleet (Del City Municipal) on her March 2007 report. Respondent's failure to report these bonds resulted in unpaid reviewal fees of \$53.45 and in Respondent exceeding her writing limit by \$4,505.40. The bonds were subsequently reported on June 6, 2007, and the reviewal fee paid on June 4, 2007.

4. Respondent failed to timely report bonds on Samuel Grisby (Oklahoma City Municipal 052551066 and 052551048), Paul Hayes, and Roy Munoz on her May 2007 report. Respondent also failed to submit reviewal fees of \$89.74.

5. Respondent failed to timely report bonds on Armondo Valtierra, Laquentin McDaniel and Bryan McCollum on her June 2007 report. Respondent subsequently reported these bonds on her July 2007 report.

6. Respondent failed to timely subrnit reviewal fees of \$48.12 with her August 2007 report.

7. Respondent failed to timely report seventeen (17) bonds on her September 2007 report and failed to submit reviewal fees of \$111.50. Respondent also exceeded her writing limit by \$38,379.00

8. Respondent failed to timely report three (3) bonds on her October 2007 report.

9. Respondent failed to timely report three (3) bonds on her November 2007 report.

10. Respondent failed to file her December 2007 monthly simplified surety monthly report by January 15, 2008.

11. Respondent failed to timely report one (1) bond on her December 2007 report and again exceeded her writing limit by \$16,799.00.

12. Respondent failed to timely file her December 2007 monthly professional report.

### **CONCLUSIONS OF LAW**

1. Respondent has violated OKLA. STAT. tit. 59, § 1310(A)(22),(23), 1314(B), and OKLA. ADMIN. CODE 365:25-5-36 by failing to report bonds on her January 2007, February 2007, March 2007, April 2007, May 200, June 2007, September 2007, October 2007, November 2007, December 2007, and her January 2008 monthly professional reports.

2. Respondent has violated 1310(A)(22) and 1314(D) by failing to submit a reviewal fee for the bonds she failed to report on her January 2007, February 2007, March 2007, April 2007, May 2007, June 2007, September 2007, October 2007,

November 2007, December 2007 and her January 2008 monthly professional reports.

3. As a result of Respondent's failure to report bonds, she has violated OKLA. STAT. tit. 59, § 1306(A)(3) by exceeding her writing limit of 10:1 for the months of March 2007, April 2007, September 2007, and December 2007.


4. Respondent has violated OKLA. STAT. tit. 59, § 1310(A)(22), 1314(B), and OKLA. ADMIN. CODE 365:25-5-36 by failing to timely file her December 2007 monthly simplified surety report and failing to timely file her December 2007 monthly professional report.

#### ORDER AND CONSENT

IT IS THEREFORE ORDERED by the Insurance Commissioner and CONSENTED to by the Respondent that Respondent shall be and hereby is fined in the amount of **Four Hundred and No/100 Dollars (\$400.00)**. It is also agreed Fine is to be paid immediately.

IT IS ALSO AGREED by the parties that Respondent's counsel, Thomas Hosty, shall accept all future service on behalf of Respondent and that counsel shall work with Respondent to insure that all bonds are timely and accurately reported and that Respondent complies with all statutory provisions in the Bail Bond Code.




