**CONSENT ORDER**

COMES NOW the State of Oklahoma, ex rel. Kim Holland, Insurance Commissioner, and the Respondent Bruce Hancock (hereinafter Respondent), and enter into this Consent Order.

**JURISDICTION**

1. That the Insurance Commissioner has jurisdiction of this cause, pursuant to the provisions of the Oklahoma Bail Bond Code, OKLA. STAT. tit. 59, §§ 1301-1340.
2. That Respondent is a licensed bail bondsman in the State of Oklahoma holding license number 800290/199958.
3. That Respondent has been apprised of his rights including the right to a public hearing and has knowingly and freely waived said rights and enters into this Consent Order as a voluntary settlement to the issues and questions raised in the above captioned case.

31. The Defendant was not returned to custody within ninety (90) days nor was the forfeiture paid within ninety-one (91) days.

32. The forfeiture was untimely paid on April 15, 2008.

**CONCLUSIONS OF LAW**

1. Respondent has violated OKLA. STAT. tit. 59, § 1332(D) eight (8) times by failing to deposit cash or other valuable securities in the face amount of the bond with the Court Clerk ninety-one (91) days from receipt or mailing of the Order and Judgment of Forfeiture from the Court Clerk.

**ORDER AND CONSENT**

IT IS THEREFORE ORDERED by the Insurance Commissioner and CONSENTED to by the Respondent that he shall be and hereby is fined in the amount of Four Thousand Two Hundred Fifty and No/100 Dollars (\$4,250.00).

IT IS FURTHER ORDERED by the Insurance Commissioner and CONSENTED to by the Respondent that Respondent must remit payment by certified check or money order in the amount of Four Hundred Twenty-five and No/100 Dollars (\$425.00) by 5:00 o'clock p.m. on April 18, 2008, along with a signed copy of this agreement. If Respondent fails to pay this amount as provided herein, Respondent's license shall be immediately suspended until the total amount of the fine is paid in full.

IT IS FURTHER ORDERED by the Insurance Commissioner and CONSENTED to by the Respondent that he shall remit a monthly payment of Eight Hundred and No/100 Dollars

(\$800.00) by the 15<sup>th</sup> of each month until the above referenced fine is paid in full. The first Eight Hundred and No/100 Dollars (\$800.00) payment is to be received by Petitioner no later than 5:00 o'clock p.m. on May 15, 2008. The second payment is to be received by Petitioner no later than 5:00 o'clock p.m. on June 15, 2008. The third payment is to be received by Petitioner no later than 5:00 o'clock p.m. on July 15, 2008. The forth payment is to be received by Petitioner no later than 5:00 o'clock p.m. on August 15, 2008. The fifth and final payment is to be received by Petitioner no later than 5:00 o'clock p.m. on September 15, 2008. If Respondent fails to make any payment by certified check or money order by the specified date and time, Respondent's license shall be immediately suspended. Respondent's license shall remain suspended until the total amount of the fine is paid in full.


