1. That the Insurance Commissioner has jurisdiction of this cause, pursuant to the provisions of the Oklahoma Bail Bond Code, OKLA. STAT. tit. 59, §§ 1301-1340.
2. That Respondent is a licensed bail bondsman in the State of Oklahoma holding license number 800767/199655.
3. That Respondent has been apprised of her rights including the right to a public hearing and has knowingly and freely waived said rights and enters into this Consent Order as a voluntary settlement to the issues and questions raised in the above captioned case.

**STIPULATIONS OF FACT**

1. Respondent failed to file her February 2008 monthly cash report by March 17, 2008. Said report was received by Petitioner on April 17, 2008.
2. Respondent failed to file her March 2008 monthly cash report by May 15, 2008. Said report was received by Petitioner on May 27, 2008.

**CONCLUSIONS OF LAW**

1. Respondent has violated OKLA. STAT. tit. 59, § 1310(A)(22), 1314(B), and OKLA.

ADMIN. CODE 365:25-5-36 by failing to timely file her February 2008 and April 2008 monthly cash report.


**ORDER AND CONSENT**


